County Highways of Columbia

County and Placing a Limit on

Loads to be Hauled Thereon.

This matter coming on to be heard

on this 7th day of November, 1921,

before the County Court for Colum-

bia County, Oregon, sitting for the

transaction of county business, and

appearing to the court from a per-

sonal inspection of said county high-

ways, that the same are being per-

manently damaged by the use of ve-

hicles conveying heavy loads over

said highways, and it appearing that

it is the duty of this court, under

authority invested in it by law, to

regulate by order, the weight of

loads drawn over and upon said

County Highways:

NOW THEREFORE IT IS HEREBY ORDERED AND ADJUDGED,

that from and after the date of this

order, until the same is revoked by

further order of this Court, that it

shall be unlawful for any person,

firm or corporation to haul or trans-

port over any county highway of the

said Columbia County, Oregon, in

any vehicle, any load weighing in

excess of THREE THOUSAND

pounds, provided however, that loads

not in excess of FOUR THOUSAND

pounds may be hauled over said

County Highways in vehicles hav-

ing a total tire width of 24 inches

or more than 24 inches; provided

further that this order shall not apply

to any load hauled over any hard

surface highway; and provided fur-

ther that the County Roadmaster may

grant permission to haul loads in

excess of the above mentioned load

limits when in his judgment such per-

mission is advisable under the cir-

cumstances and conditions.

And it is further ordered that

proper signs conveying notice of this

order and the contents thereof shall

be posted by the Roadmaster at each

end of each and every highway cov-

ered by this order.
