#### PAYS TO THIN ORCHARD.

Thinning of pears and apples is work that will pay the grower large returns and should be carried on in every commercial orchard in county and by the small growers as well. According to lengthy experiments carried on by the Oregon Agricultural college, it has been prov en that the proper distance of thinning on apples and pears is 6 and 7 inches apart. All clusters should be broken and fruit well spaced on the




