CHANGE SYSTEM TO CONTROL WHEAT property, to-wit:

Stinking Smut of Wheat May be Checked or Eradicated Through Adoption of Proper Methods.

Bunt, or stinking smut of wheat, the cause of the great crop losses in Oregon and other states, may be controlled or completely eradicated through planting resistant or immume varieties rapidly being developed, it is reported by Horace Woolman, field agent, office of cereal investigations, United States Department of Agriculture.

Wheat bunt can be controlled only by an entire change in the system of farming or by production of re-sistant varieties, the Oregon Agricultural experiment station believes. Rapid progress is being made by the station and it is the belief of the specialists that it will be but a short time before all the susceptible varieties of wheat grown in Oregon can be replaced by immune or highly resistant ones having all other desirable qualities.

NOTICE TO FRUIT GROWERS AND DEALERS.

Attention is called to the following extracts from 1920 horticultural laws of Oregon:

Par. 8881. It shall be unlawful 11, A. for any person, firm or corporation 12, A. to import or sell any infested or di-seased fruit of any kind in the state 14, A. of Oregon, except that such fruit 15, A. A. Anderson may be sold to evaporators, fruit 16, A. A. Anderson canneries, fruit product factories, or other by-product factories under the 17, A. A. Anderson following conditions:

First. Such fruit so sold shall be used solely for the production of manufactured fruit products, beverages, or other manufactured products, or by-products. Second. The nature of the infes-

tation or infection shall not be such as to make the article of food or beverage manufactured from such fruit unhealthful or unfit for use as a food or beverage.

As the foregoing extract declares it unlawful to sell infested or di-seased fruit, notice is hereby given that after September 10th inspec-16, Wm. tions will be made of all fruit found in hands of dealers, and wherever 12. same is found to be infected with 13.
