PUBLIC SCHOOL Vote 314 x Yes

The purpose of the compulsory public school attendance bill is to insura the instruction of all Oregon children of grammar school age in a common language, a common history and common ideals, to the end that American unity shall be promoted, American ideals safeguarded and American Institutions perpetuated.

This bill is proposed because its supporters believe that only by universal education of our children on standard and uniform lines can these things be

This bill proposes no religious restrictions. It contemplates no limitation of the right of the parent to teach religion to his child in his own way and according to his own belief. It raises no issue of religious difference.

This bill is purely a measure to insure that all children by attending the public schools shall be taught alike during their grammar school years, so that their outlook may grow to be a unified outlook for the common weal and for their country and its institutions

To make an all-American nation we must have all-American instruction deals and institutions and language is the greatest menace to them, becau those who do not understand them properly do not support them





FORD CAR PRICES TAKE \$50 DROP

According to information con-veyed to the Fieldhouse Motor company from the general offices of the Ford Motor Car company, there has been a reduction of \$50 per car on the several models which the Ford company puts out. "The remotion in price is effective immediately, Mr. Fieldhouse said "and our company will deliver cars at the new prices. The price of the new touring car is \$298, f. o. b. Detroit, which is much lower than the pre-war price. Before the war this car was priced at \$360 at factory and the reduction Mr. Ford has made brings the price down to \$298, a reduction of \$62 from the pre-war price. Other Ford cars have been proportion-ately reduced and I believe it will be difficult to supply the demand at the new low prices.
