The school at Tryon is progressing finely under the management of Mrs. Mary Severn. She has about sixteen pupils enrolled.

The plastering in the new Masonic hall at Rainier is nearly completed. When finished, the people of Rainier can well be proud of a fine hall.

Mrs. John Scott, of this place, is having an addition built on her house next door to the Masonic hall preparatory to occupancy as soon as it is done.

Considerable new sidewalk is being built in Rainier. St. Helens should make a move in sidewalk building. Most of the walks in town are old and worn out, and new ones are much needed.

Muckle Bros. mill will start up in about two weeks for a short run, for the purpose of filling up the yard and saving out a few local orders. They have some hopes of securing larger orders from California soon.

Mrs. M. Richardson and son, Dan, have moved to Portland, leaving Wednesday. Mrs. Richardson some time ago purchased property at Fulton Park, Portland, and has had a neat cottage built thereon in which herself and son will in the future reside.

Mrs. C. E. Walker closes her sixth term of school at Mayer, March 10. Mrs. Walker is a successful teacher and the people of Mayer are fortunate in having secured her services so long. The district has a neat little school house, but new seats are much needed.

The steamer T. J. Potter and Telephone are having a warm contest in point of speed. Sometimes one is a little ahead and sometimes the other. As the Potter carries the mail she probably has to make more landings than the Telephone, consequently she is generally a little behind.

Commencing yesterday the Union Pacific steamers, T. J. Potter and R. R. Thompson, reduced the passenger rate from Portland to Astoria to \$1 each way or \$1.50 for round trip tickets. This is done with a view to compelling the Telephone to abandon the route.

The Columbia River Fisherman's Union have fixed the price of salmon at \$1 each for the coming season. The cannerymen have not yet accepted the rate as fixed by the union, but it is quite probable that they will do so in due time. Great preparations are now being made all along the river for a large run this summer.

It will consist of spars and shingles, with 400,000 feet of lumber from the mill. The Sintram is a splendid vessel, drawing 21 feet of water. Six of her crew have deserted since she arrived at Rainier—two of them escaping on a rope 200 feet long, which was fastened to a tree on the shore.

On Thursday night of last week Mr. and Mrs. H. P. Watkins gave a house warming party to their many friends in St. Helens and vicinity. Mr. Watkins has just completed his new and cozy residence, which is large and very conveniently arranged throughout, and the invitation that they intended to give a party upon the completion, was realized on the above mentioned evening. The large building was illuminated throughout with glowing lights, giving it the appearance, at a little distance, of a small city. The invitations had been sent out a few days before, and by 7:30 the crowd began to assemble. By 8 o'clock the house seemed as if it would not shelter another person, but still they came, one, two, and three in a group for sometime afterwards. For those who love to trip the fantastic toe, the host and hostess had not forgotten to provide. The large sitting room and parlor, being only separated by two folding doors, were soon converted into one room practically, and in the former there was room to dance one set, while the latter afforded ample room for two sets, and the musicians were located between. Three sets were on the floor at a time almost continuously during the evening. In another room those who preferred were provided with tables, chairs and cigars and various games at cards were indulged in by the older ones. And still another room was set apart for social conversation which was well filled all the time. But here we come to the important but none the less enjoyable part of the entertainment—the supper. The table fairly groined under its load of delicacies and substantialities. Here there was no preference shown as the crowd all mingled together around the festive board and did ample justice to the occasion. To say that those tables looked inviting does not express it. All went smoothly until about 2 o'clock in the morning when the crowd departed for their several homes feeling that they had enjoyed the fullest hospitality of their townspeople, Mr. and Mrs. H. P. Watkins.

E. H. Flagg, formerly of St. Helens, where he edited THE MIST, and later of Hillsboro, where he was connected with the Independent, has decided to start a democratic newspaper in Salem. Mr. Flagg is quite well known throughout the state as a successful newspaper man and an active democrat and will no doubt give his party a good paper here. He has leased a building opposite the State Insurance office in which to put his plant. He will have his own presses and will do a general job printing business. He was in Salem a part of last week and has concluded the preliminary work of his canvass. The canvass will be published for the first time in about three weeks. It will be an eight-page six-column sheet and will be published every Monday morning. Mr. Flagg has not yet decided upon a name for his paper. He will at once bring his family to this city, prepared to abide permanently in Salem—Statesman.

At the annual school meeting held at the court house Monday evening Mr. A. H. Blakeley was elected a director for a term of three years and Mr. A. H. George re-elected clerk for one year. After the election of officers the question of voting a special tax was taken up and after considerable discussion a motion prevailed to make a tax levy of 10 mills for school purposes. The motion, upon a vote by ballot, was carried by several majorities, after which a discussion arose as to who should be employed to teach the summer school. Mr. Jones, who has taught the school for the past six months, and who has also given general satisfaction, was the recipient of the almost unanimous endorsement of the meeting. Mr. Jones is certainly the best teacher the district has had for years, and it would surely be an unwise move to look further for a teacher while he is here and willing to continue in charge.

It is now understood that the steamer Toledo, of the Lewis river route, has not yet been sold to the Mascot company, but that the stockholders of the Toledo are having a real hot wrangle about the matter of selling a price on their property, and in the meantime the Mascot has a monopoly of the business while the Toledo is tied up in Portland. Common sense never comes to the rescue when loggerheads are at the helm.

Court is in session this week with Judge Switzer, Commissioners Barnes, of Mayer, and Spencer, of Vernonia present, constituting a full board. A number of road petitions have been presented to the court from various parts of the county, and also recommendations from several sources asking to have certain bridges repaired. The court will probably finish its labors today.

Mr. C. H. Jones has been re-engaged to teach the summer term of school in St. Helens, commencing next Monday morning. The school is now an assured success and all the pupils, assisted by the good advice of their parents, should strive to reach, as near as possible, the summit while they have such an efficient teacher.

We learn that the 2-year-old son of Mr. F. D. Henrici, of Sauvie Island, broke his right arm about midway between his elbow and wrist Wednesday evening. Mr. Henrici brought him to St. Helens late in the evening and Dr. Cliff administered relief to the little fellow, who is now getting along nicely.

The Harry Morse, of San Francisco, J. Hughes, captain, is taking a cargo of lumber from Borwick's mill for Mexico. She will sail in a few days. Mr. Borwick expects to have another ship to load as soon as the Harry Morse sails.

The dedication of the new church at Houlton takes place next Sunday at 11 o'clock, at which time the presiding elder of the Evangelical church will be present. A large crowd is expected to be present.

The new propeller steamer, being built at Kelo, will be launched in a few weeks. It is about the size of the Fraids, and is intended for a daily boat between Portland and Kelo.

Deputy District Attorney A. S. Dresser, of Oregon City, was in town Wednesday on official business.

Mrs. R. Searcy and daughter Cloe, visited at Gillton this week.

From a private letter from Rev. Jordan we are informed that he will not be able to preach here next Sunday.

The Rainier city election took place last Monday. We have been unable to learn the result.

Nils Thompson filed on Wednesday on the 2nd of section 30, township 6 north, range 2 west.

The county court has appointed J. B. Duncan, of Scappoose, as justice of the peace, vice W. V. West resigned.

The sheriff has completed his tour through the county collecting taxes, and reports fair success in most sections.

Mr. and Mrs. James Muckle gave a very pleasant party to a number of their friends on Wednesday evening, which all present enjoyed immensely.

Mr. C. L. Colburn, a Portland barber, has rented the old saloon building of A. H. Blakeley and will open up a barber shop soon. Mrs. Colburn will also carry on a dressmaking and millinery business.

Mrs. S. S. Way has again been employed as assistant teacher in the St. Helens school. Mrs. Way has had charge of the primary department of the school for the past three months and has given general satisfaction.

Justice J. B. Doan, of Rainier, was a visitor at the county seat yesterday. He reports that the farmers in his locality are busily engaged in plowing and seeding this fine weather, and some have already planted corn considerable spring grain.

The pupils of the St. Helens public school, as a token of the high regard they have for their late teacher, Mr. C. H. Jones, presented that gentleman, on Friday last, with a very handsome gold headed cane. In a few well chosen remarks the presentation was made on behalf of the school by Mr. Kendall Blakeley, and since that time Mr. Jones has reason to believe that his efforts in school work in St. Helens have been duly appreciated.

Three road surveys were ordered by the county court at its March session this week. On the upper Nehalem, the viewers for each of the roads are J. T. Solomon, John H. Adams and Edward Webster, and are to meet for the survey of the first road at Judson Weid's, on April 5th; for the survey of the second road at A. B. Lewis' on April 8th; for the survey of the third road at H. C. Brinson's, on April 12th. A survey of what is known as the Doan road was ordered, beginning April 18th, to meet at W. J. Schultz's. Viewers, O. B. Anstine, C. Solare and Walter Farrow. The survey of the Corlies road is set for April 28th, to meet at G. C. Barger's. Viewers, J. Koukle, C. N. Gable and J. C. Millard.
