This issue of THE MIST is increased over 500 copies which will be sent East and distributed along the line from here to Ogden and on to Chicago. The carefully prepared descriptive articles, it is hoped, will have a tendency to attract homeseekers to this section, capital to develop our resources and utilize our vast bodies of timber, unearse the valuable coal deposits, make use of the many water powers and open up a stage of prosperity never dreamed of, even by those who are most sanguine. By our representation at the Trans-Mississippi Congress we hope to realize handsomely, and there is no reason why we should not. A class of immigration to this county is most desired, with means enough to reach here, those who are so situated as to render themselves useful in aiding our already lively stage of activity and development. From now through the summer and fall we may expect an influx of people to this coast almost unprecedented, being brought about by those who have tired of living in the blizzard and cyclone-swept regions of the Eastern states. From their visit to the great exposition at Chicago, their tour will extend further west, with a view to permanent location. There is no reasonable excuse for Columbia county not receiving her share of these persons, who will be mostly well-to-do farmers from the East. We firmly believe that our descriptions will do no small amount of good for this county.

LIVELY scenes ensued for several hours at Astoria Saturday, between the union and nonunion fishermen, wherein some 300 union men went in a body to the wharves of two of the leading canneries, and as the sloop loaded with fish from the traps landed and begun unloading, the boatmen were compelled to surrender and give their boats and fish up to the fishermen who threw the salmon overboard. Two canneries employees interfered but were overpowered by the sturdy fishermen. Warrants were sworn out for the arrest of five of the mob. The fishermen demanded \$1.15 per fish but the cannerymen were willing to pay only per pound—4 1/2 cents. This the fishermen refused, when at last the cannerymen made the final offer of five cents per pound, which was at first accepted by few, when later the fishermen accepted the offer and agreed to go to work. It was feared that bloodshed would result from this outbreak, and probably would had there not been an immediate understanding arrived at by the fishermen and cannerymen.

WHAT proves a great benefit to one part of the county must necessarily benefit the remaining portion of the county. The flying rumors of the resumption of work on the Portland & Astoria railroad is a matter for consideration by those residing in this county. Should the road be built this summer, or even in the next two years, we will find our county's resources more extensive and of a more substantial nature, such as will prove a great financial benefit to the county. Our buried and interior resources will be developed, our volume of taxable property will be enlarged, our laboring class will be furnished lucrative employment near at home and an air of substantial business and general prosperity will be seen where now we find many things in this line generally depressed. By all means let us urge upon and aid in every way in our power, the promotion of such an enterprise that will advance and enlarge our wealth and prosperity to a standard that would place us in a position to be envied by more wealthy yet less enterprising counties.

The "confidence man" is for ever and anon bobbing up in Portland, and it seems that for each of his bobs, a greenhorn, which is easy game for him, bobs about at the same time. The latest sensation in that city is one perpetrated upon Warren C. Grant, a young laborer from Montana, who was on his way to his home in California. He was the possessor of a \$500 draft on a New York bank, and was captured by the festive "confidence" immediately upon his arrival in the city, taken to a down-town saloon, inveigled into a poker game, and in order to "see" a sure thing for \$200, endorsed the draft, and as a natural consequence, lost; the confidence man disappeared and young Grant was left broke and friendless. He immediately gave his case to the police who captured the confidence man and made him deliver over the draft and young Grant was sent on his way rejoicing, declaring he had played his last game of poker.

It is said that on a moderate estimate 10,000 young women are seeking employment in Chicago, as guides, waiters, messengers, etc. It is safe to presume that a vast majority of these eager and in many instances, needy applicants for work will be disappointed, so far as securing anything

like compensation for their labor, discomfort and anxiety goes, while no doubt, many will be betrayed into snares that are spread in large cities for unwary feet. Meanwhile housework offers in all our large cities a safe and remunerative field of labor for competent young women. The druggery connected with a position at the exposition in any of the menial avocations during the midsummer heats will make a domestic service under ordinary conditions a picnic by comparison—a fact that has been apparently lost sight of in the holiday glamor that has been thrown around the world's fair.

THE Tillamook Headlight, in its last issue, everlastingly screeches some one of the law firms in Oregon City, doing business before the land office, at that place. The Headlight charges the firm with withholding money due its publishers for timber land advertising and says it was with some difficulty that the money was finally secured at all. And furthermore says that the practice of the attorneys of collecting the advertising fee from the claimant at the time of filing is one that casts a shadow of discredit upon the standing of the newspapers, claiming that a long-established and reliable paper is as competent of taking care of the funds as is the attorney. The claimant pays the advertising fee to the attorney in good faith, and in consequence cannot be held responsible. Nevertheless, there is always more or less difficulty attending the collection of these long-due advertising accounts.

THE Eugene Guard evidently has an ax to grind with the Oregonian, at least a line or two of an editorial in a recent number of the Guard would naturally lead one to believe that it has. It refers to the Oregonian as being "the Portland nine-story, tax-dodging concern." Well, for our part, we were just congratulating ourselves upon living so near a city that could support and maintain such a paper as the above referred-to tax-dodging concern, in fact, we are nearly persuaded to deem the same as being quite an indispensable commodity.

EVIDENCES of prosperity are brought more forcibly to bear upon us every day. The establishment of a banking house in St. Helens, the first and only one in the county, is a most valuable acquisition and one that should be maintained. It is an enterprise bespeaking greatly, the rapid growth and fast accumulating wealth of our county; one that will serve as an inducement for capital to locate with us and one which will prove itself a great benefactor in general.

FROM the statistics published in the last issue of this paper it will be seen that the financial condition of the county is in excellent shape, owing to the close attention given the matter by the officials. However, the indebtedness of the county, as stated, is \$37,491.37, the resources overreaching this amount by several thousand dollars, being \$43,346.23, a difference of \$5,854.86.

An eighteen-year-old lad committed suicide at Seattle Saturday morning. It is supposed that the young man had been refused the love and affections of a young and timid girl and concluded to end his miserable existence by taking his own life.

THE Nehalem Journal has changed hands, Robert U. McNutt is now at the helm, and may he guide the Journal safely over the rippling waves to a success which is deserving one who necessarily must take the blunt of the storm.

By the most careful use of the world's fair funds it is estimated that up to May 1st the expense of the exposition will easily reach \$20,000,000.

IMPORTANT CONGRESS.

Senator Adams on the Need of Western States Combining.

(From Los Angeles Herald.)

Hon. A. P. Adams, of Rico, Colorado, state senator and a large land owner, is stopped at the Hotelbeck. He is a very affable gentleman, and bears a close resemblance to ex-Governor Adams, in a smooth, easy, conversational manner. He is the greatest of this great western country, and thinks that much can be done to hasten its prosperity. "There are twenty-two Trans-Mississippi states and territories," said Senator Adams, and our members of congress go to Washington to represent us, they get as quieted—and they don't accomplish as much as they might. We will get everything we want when we once get at it right. "There will be a congress of western states at Ogden, beginning Monday, April 24th," continued Senator Adams, "and I want to see all our congressmen there, and have them get acquainted, and agree on what to do. I understand Governor Prince, the president of the congress, has invited all of the other twenty-one governors to meet with him at the congress this session, and it is certainly to be hoped they will do so. "It will help to create that harmony and unity of purpose so much needed, more than anything else that could happen. The congress meets just one week before the opening of the world's fair, and will adjourn in time for the governors to reach Chicago for the world's fair. Just think of twenty-two governors entering Chicago from the west, on the same train. Nothing would more signally emphasize the importance of our Trans-Mississippi country. It takes an object lesson like this to teach some people. "The territory these governors represent is more than three-fourths of the United States, and represents more enterprise, energy and intellect than there is in the balance of the Western hemisphere. Once let this push and intelligent spirit get together and agree on what it wants and it will get it. "It is a novice in politics who thinks that the merit of this cause alone is going to put it through congress. You can stand up and talk San Pedro harbor till doomsday and you won't get it without effective work. Wall street has a ring in the nose of congress, and it is not in the interest of the masses till we organize as they do. "Colorado has had delegates at every session of the Trans-Mississippi Congress, and we will be at the next one to shake hands with the delegates from every state and territory that attends, and ready to pledge mutual friendship. "All I have to say to you people of California is that if you know what you want and want to get it, come in with us."

THE Trans-Mississippi Congress. The Trans-Mississippi Congress held its first session at Galveston three years ago. Its second session was held at Denver about six months later. It met a third time at Omaha, and fixed New Orleans as its place to meet next. The meeting at New Orleans was its fourth and the congress assembled in that city on February 1st. This made four meetings of the congress east of the Rocky Mountains, and it was decided to hold its next session west of the Rocky Mountains. A committee was selected as the place on account of the railroad facilities for reaching that city from all parts of the far West, its fine operating and other commercial advantages, and a large assemblage. May 2, 1893, was fixed as the time. But on account of this date conflicting with the World's Fair opening, the executive committee has changed the date to Monday, April 24.

The territory embraced in the representation to this congress takes in all of the United States except the states of California and that small part of Louisiana and Minnesota east of the river. The basis of representation is as follows: Each state and territory has the right to appoint ten delegates; the county commissioners or county judges may name the delegate from each county; the mayors of all towns and cities select one delegate for each 5000 people or fractional part thereof, and no matter how small the town may be, if it has a mayor or a delegate, all commercial bodies in all towns and cities may appoint the same number as the mayor. This last includes chambers of commerce, real estate exchanges, and all similar commercial bodies; each of these can be represented by as many delegates as the city from which they come is entitled to.

All transportation companies, whether rail or steamship are entitled to one delegate each. Governors, mayors, county judges, and presidents or chiefs of county supervisors are ex-officio delegates to the congress. The object of the congress is to discuss all questions affecting the West that may be subject to legislation at Washington, and to speak through its resolutions to the National Congress. Hence irrigation, arid lands, river public lands, the policy of the secretary of the interior, Pacific and Gulf coast harbors, and many other important questions in a body composed entirely of western men.

This is the most important representative assembly of the West. It has already influenced legislation, notably measures for the improvement of the Mississippi river. The congress is becoming better known and more influential with each session. It is the earnest desire of the officers and friends of the congress, that the next session should be attended by the governors and congressmen of the twenty-two Trans-Mississippi states, with a view to the harmony and unity of action in legislation in the interest of the West.

FROM FISHHAWK. Editor Mtr.—We all rejoice to see beautiful spring once more, and that winter having been unusually disagreeable, and it brings to mind that we must have some bitter along with the sweet that we may be able to appreciate the pleasant things when they come, otherwise we might be dissatisfied, even in the Garden of Eden or in the land where milk and honey flow. We are now in a superbly beautiful water flow and we must make the best of it.

The main topic of the day seems to be "will the railroad be built?" We have been credibly informed that a party of men have been making a preliminary examination of what is known as the "Iron Horse" route. It looks like they aimed to do something soon. We also hear that in order to overcome the great difficulties of tunneling Sadde mountain they intend to make such a cut as fine fir and cedar timber as was ever cut from the Columbia valley. All this is waiting for capital and enterprise coupled with brain and brawn, to take hold and develop the natural resources which are to be found in the vast vegetable and mineral wealth of northwestern Oregon. We may, at least, console ourselves in a hope that in the near future we may enjoy a full realization of our vision.

We are pleased to note the fact that the Clatskanie logging tramway has become a certainty. Now that the ball is rolling, we predict that this same scheme will not stop until it penetrates the Nehalem valley, and will be the means of developing a more extensive region than is generally supposed by the outside world. We may live to see this vast forest region enlivened by the hum of the various kinds of wood-working machinery and the gloom of the wilderness be dispelled by the light of the iron horse of commerce. Then will the iron soil be tickled by the modern implements of agriculture and the little valleys will yield up their stores of grain to the persevering and sturdy husbandman. The many fertile fruit ranches will be dotted by a thousand fruit ranches, while the natural resources in the way of water powers will be developed and utilized in generating electricity, and many other useful purposes.

COLUMBIA'S REPRESENTATIVE.
