SEEK GETS THERE.—While the steamer Kellogg is on the ways being repaired after the damage done her in Cowitz river some time ago, the City of Frankfort is on her route on the same schedule. She is a little slow, but gets there just the same.

PERMISSIVE SHOOTING.—Considerable complaint is being made by stockmen on Sauvie's island that duck-hunters have been killing stock, perhaps accidentally, but nevertheless some stock has been killed. The hunters should be more careful in what direction their aim is taken, and above all see that no stock is in range.

VEGETABLES.—The old familiar face of Mr. Charles English is again seen on our streets, in the vegetable business. Mr. English for years supplied St. Helens with garden truck, but on entering the mercantile business some two years ago he abandoned market gardening temporarily until now, and in the meantime our people have been supplied in that line from various sources.

CHANGE OF VENUE.—In the circuit court this week the bond cases of Columbia county vs W. A. Meeker and G. A. Massie came up, and a change of venue to Multnomah county was asked and was granted by the court. So now these two important cases will leave the county for trial, and owing to the large amount of business before the court of Multnomah county it will very likely be some time before the cases will come to trial.

HOSPITAL SURGERY.—Dr. Ross will leave on Monday next for Portland, where he has been engaged as surgeon in St. Vincent hospital for several months. This institution employs two surgeons all the time, and in their selection Dr. Ross the management have, in our opinion, shown good judgment. During the doctor's absence Mr. L. B. Sturt, who is a competent and reliable pharmacist, will have charge of the city drug store.

OSWEGO SCHOOLS.—This office acknowledges the receipt of a neatly gotten up catalogue of the Oswego public schools, Professor C. H. Jones, principal, giving among other things, the rules, course of study and methods in general practiced in the school; also a tabulated list of all pupils enrolled. The school is graded into eight departments, and if the laws and rules laid down in the catalogue are adhered to the school is certainly a model one.

PRUNE PROSPECTS.—Norris Humphreys informs us that at present prices he can realize \$3500 from his dried prunes, raised on his 25-acre orchard, a few miles north of Eugene, says the Guard. The trees are six years old, and have been thoroughly and intelligently cultivated. His entire cost, drying, picking, and cultivating, will probably amount to between \$1000 and \$1250, leaving the balance as profit. The fruit business is certainly a profitable one, when properly attended to.

VERDICT OF GUILTY.—The criminal case of the State of Oregon vs W. J. Rice began in the circuit court last Friday on indictment charging assault with a dangerous weapon. The case consumed all day Friday, Saturday, and Monday, and went to the jury Tuesday morning, who, after being out about four hours, brought in a verdict of assault, and the defendant was given time to file a motion for a new trial. The jury were Daniel Swiney, Joseph Coulter, Chas. M. Graham, Adam Barr, Henry Lamberson, Edward Voaberg, Chas. Brant, Andrew Elliott, Jno. W. Bools, Michael Fresh, A. N. Clark, and John Urie.

CONVICTED OF BURGLARY.—The case of H. J. Lynch, indicted for burglary, was tried last week in the circuit court and after the jury had been out about 12 hours they returned a verdict of guilty as charged in the indictment. The indictment charged Lynch with the burglary of some harness in the vicinity of Clatskanie, and after the details had been thoroughly investigated the case went to the jury Thursday night, and on Friday morning they came into court to review the testimony and receive additional instructions, after which they shortly agreed as above stated. The defendant's attorney, G. O. Holman, argued a motion for a new trial.

MORE REFORM.—The so-called reform in the Oregon City land office is liable to prove expensive to some people in Columbia county. A number of persons have made final proof on their claims in this county within the past few months, and their papers forwarded to the land office, which were sent up, in accordance with those previously sent, and have been returned as irregular. The papers returned were identical with those previously accepted. The mistake was that in the advertisement the person before whom the proof would be made and the county judge had performed the work, but why former papers bearing the same error had not been rejected we leave it to the public to judge. One thing is certain the burden will fall heavily on any who may be compelled to make proof a second time, and it seems they should not be made suffer in consequence of this error on the part of those who are appointed to execute the law.

THAT ROCK CREEK SCHOOL.

KEASBY, Oregon, Oct. 29, 1894. EDITORS MIST:—That attack upon this school district and board of directors that appeared two weeks since in your paper is known here to be the work of an irresponsible person who would not be worth replying to but for the fact that your paper having a large circulation over the entire county, many outsiders may be led to believe that they elect such men as we were reported to be. So in defense of our district I am reluctantly compelled to take notice of it.

As to the first charge "that school boards are apt to do dishonorable things in order to gain notoriety," which "Citizen" makes, I will say that I don't know whether school directors will do more dishonorable things to attract notoriety than folks connected with the United States mail or other public office; neither do I care. But I do know that we hired Miss Guild to teach our school and she gave as good satisfaction as the average young teacher. When her time was up we found we could get an older and better teacher, and as we had promised Miss Guild nothing further than for what she was hired, we simply say she is free. As for her reputation, we have never spoken any well of her. But if her indiscreet friend, "Citizen," makes any more such charges as the one about her falling to her contract with the Tillamook school, it will not do either of them any good; and I fall to see what that has to do with us directors of the Rock Creek school. I will say, however, that I don't believe Miss Guild ever broke any contract, for in her letter accepting the school here she made no mention of it, but simply says she answers our letter and accepts our school immediately upon receipt of our letter tendering her the same. As to her being an "exemplary Christian," we have no doubt; but either "Citizen" has been vaccinated or else it ain't catchin'.

As to making a change in order to accommodate a distant relative and settler here, we did speak of that as one of the incidental advantages to be gained, believing in protection to workmen, and that the money spent in improving the valley and helping settlers here is better than if sent outside to another county. I am ever ready to practice what I preach, and that as one of the principal reasons I tendered the school of the start to this same correspondent, who now spreads scandal about us, who are her friends and neighbors. But she failed to sign a contract, and teach our school for reasons we know, and she fails to give. And I still fall to see the crime in following out this idea, because indirectly the benefits help a relative.

Now as to the main point. Our last teacher is the best we have ever had in the district. Every parent who had children attending are well satisfied. Not one word of complaint has been made by anyone who has visited the school. There is not a district in the state where all are better suited in every way with regard to school methods than are the people of the Rock Creek school. But we are not perfect—there is one "citizen" that prevents it. Now, in conclusion, let me say that I always get along well with my neighbors by treating ladies with the respect due them. When dealing with gentlemen I treat them as such, but a "citizen" ab! the citizen is something new, and perhaps one too many for me.

Expecting to end matters so far as I am concerned, I am respectfully, one of the directors of school district No. 27.

A Deer in the Breakers.

A novel deer hunt was indulged in by the steamer Roberts last Sunday, while waiting at the mouth of the Siuslaw for the schooner Mayflower to come, says the Yakima news. A deer was observed running down to the water. It plunged in and started to swim across the stream. The log gave chase and soon caught up with the animal, but all attempts to land it were prevented by the heavy wind and heavy spray. After many fruitless attempts to capture the deer got into shoal water and escaped, much to the chagrin of its pursuers.

Sixteen Burned to Death.

SEATTLE, Oct. 27.—Sixteen dead, several injured, and the loss of \$17,225 worth of property are the results of the terrible fire in the West Street hotel, corner of West and Columbia streets, at 1 o'clock this morning. The fire was extinguished at 1:30 o'clock, and by 9 this morning sixteen bodies had been taken out of the ruins.

LIST OF THE DEAD. Mrs. Otterson, of California, aged 60; Andy Otterson, her son, aged 16; Mrs. J. W. Hoffman, of Falls City, wife of a farmer; Mrs. J. H. Hancock, of Rolfs, Iowa, daughter of Mrs. Hoffman; three children and girl aged 2 1/2 years; John F. Anderson, aged 28; F. Ballman, Angus McDonald, C. Wilson, M. Sorley, C. Graham and three unknown men.

The injured at the hospitals are: D. B. Glass, back broken and head cut, both ankles broken, may die; Ed Havenin, head cut badly, back hurt; C. B. Johnson, hands burned.

The identification of some of the bodies will not be complete for several days, and in some cases probably never.

How the fire started is best told by Spencer Butler, son of the proprietor, who is night clerk: "About 1 o'clock this morning," said he, "I went to the kitchen, which is at the head of the stairs, to get my lunch-oven. I lighted a coal-oil lamp, and then I heard a noise downstairs, and went to see what was the matter. Then I heard an explosion upstairs, and when I ran up the steps the kitchen was all ablaze. The lamp had exploded, and the table, floor and walls were on fire. I tried to put out the fire, but could not do so."

A New Steamboat. PORTLAND, Oct. 29.—The Oregon Railway & Navigation Company has ordered the material and will at once have work commenced on the construction of a steamer to take the place of the Willamette Chief, which was burned on the ways where she was being repaired, at the time the elevator was destroyed. She will be 164 feet between perpendiculars, 34 feet beam and 5 feet depth of hold. She will carry 275 tons, with a draught of 4 1/2 feet, and when light will draw 16 inches. It sounded like old times to hear an Oregon Railway & Navigation Company official say yesterday, "She will be built at our yard by P. Carstens, our boat-builder." It has been so long since the company was in the business of building boats that some have forgotten where their boatyard is, but the boatyard is in evidence rather permanently. However, all that will soon be changed and new boats will take the place of old ones.

Cut and Mashed to Pieces. PENDLETON, Oct. 30.—Napoleon B. Stover, an engine-wiper, fell before an engine this evening which was detached from the Oregon Railway & Navigation freight train. The body was carried 130 feet, where it was left by the freight engine. The Portland-bound passenger train pulled in and the engine ran over the body twice, going to and coming up from the yard. Conductor Miller, of the passenger train, was told by a yard employe that a hat and broken lantern had been found. He searched and discovered the body, literally crushed to a pulp. The trunk of the body was nearly cut in two at the hips. Fragments were wiped up along the track for the whole distance it was dragged. No less than 100 pieces were found. Stover had been employed here six years. He left a widow and seven children. Coroner Kimery immediately empaneled a jury, which rendered a verdict in accordance with these facts.

Floating Dangers. Coasting captains and seagoing men generally are much worried on account of the vast number of piles of drift along the coast from the log raft and in the old lanes, abandoned a few days ago. They say the piles are more dangerous than rocks, especially to steamers, and characterize the scheme for towing a raft of piles to San Francisco at this season as idiotic. If the raft had been made up in the winter and started out in the spring, it might have been towed to San Francisco successfully. It is probable that the next congress will be asked to make a law preventing attempts of any one from going to sea with rafts or anything else over which they cannot maintain some control. The piles are not likely to remain long a menace to navigation as they will soon be added to the vast pile of drift which lines the coast of Oregon.

Many Times Told. An exchange says the following happened in a little town in Southern Illinois in a section where the farmers alliance is strong, and a lodge of that organization exists in the town and meets on Monday nights: There is only one lodge room in the town, and on Tuesday nights it is occupied by the Knights of Pythias lodge.

The president of one of the county sub-alliances came to town one day. He had visited the town alliance, and when he saw lights in the lodge room concluded he would go over and condescend with the brethren. He gave the proper knock at the outer door. The wicket was raised, and an ear was placed at it to hear the password. "I plow, I hoe, I spade," whispered the Alliance man. The ear was replaced by an eye, and it in turn gave place to a mouth, which yelled in reply: "The hell you do!" and the wicket dropped with a bang. The indignant farmer shortly afterward met a brother, to whom he told his tale of woe.

"Why, dad blame it!" was the sharp comment of the brother. "them's Knights of Pythias, and you've given 'em our password."
