GRADING BRIDGE.—A dispatch to the Oregonian from Astoria states that grading on the Astoria-Goble road was begun at Tom's Point on Wednesday, under the direction of Contractor Wattle, of the firm of Coray Bros. & Wattle, of Salt Lake. The force is yet small, but it will be increased as rapidly as possible.

REDEMPTION WARRANTS.—The county treasurer, Mr. Wharton, has issued another call for warrants. There is now sufficient funds on hand to pay off all warrants issued up to May 17, 1893, and interest on the same will cease after this date. Mr. Wharton is always very prompt in calling in warrants as soon as there is funds on hand sufficient to justify, thereby saving to the county the accruing interest.

BOARD OF EQUALIZATION.—The county board of equalization, composed of Assessor White, Judge Blanchard and Clerk Weed, was in session Monday, Tuesday and Wednesday for the purpose of hearing the petitions of any who thought their assessment unjust. There were not a great many complaints entered, however, and consequently few changes to be made in the original assessment.

A BRAVE GIRL.—Miss Frankie Way, who has been spending some time on their Bunker Hill ranch, had quite an unpleasant experience one night last week. She started out about 7 o'clock in the evening to search for the cows. Soon after night came on and not being familiar with the woods she lost her way and wandered about until midnight before she found the road leading home. Miss Frankie is a brave girl, but admits she was somewhat lonesome during her midnight wanderings.

In Mr. Dolman's absence Mr. Alfred Harrison and Miss Anna Merrill have charge of the store and postoffice respectively. It might be said in this connection that for strictly business capacity Mr. Harrison has few equals, while Miss Merrill's office in the postoffice is attested by its many patrons.

SOMETHING WRONG.—A gentleman was in from Pittsburg Monday and informed us that THE MIST does not reach that place until the following Monday after it is published, and that this had been the case for the past six weeks. We also received a letter from the postmaster at Pittsburg a few days ago stating that the issue of August 16th had not yet reached there. The paper is mailed here regularly every Thursday evening, and there seems no good reason why it should not reach its destination in due time.

IT IS SHOWN BY ANALYSIS OF census figures that more than half the men in twenty-eight of the forty-nine states and territories are engaged in agriculture, and that farming is the leading pursuit in all of them except New Hampshire, Massachusetts, Rhode Island, Connecticut and New Jersey, where manufacturing and mechanics arts take the lead. There are in the United States 9,600,000 men engaged in agriculture to 9,220,000 in other forms of business. The steady growth of this country is sufficient proof that intelligent farming pays.

DELINQUENT TAXES.—The delinquent tax list this year is considerably smaller than usual. One reason for this is that Sheriff Don has been very lenient with taxpayers, giving them time in which to raise money with which to liquidate, and another is that the list does not include the property upon which the taxes are delinquent this year that was bid in by the county last year. While the tax was already delinquent on April 1st last, the sheriff and county court have extended the time as far as possible, affording every opportunity for delinquents to pay up.

WILL PICK HOPE.—A number of young men and boys left this place yesterday for the hop yards of Yamhill and other valley counties. Some go with the fond expectation of making a "stake," while others go for the purpose of having a good time more than anything else. Hop-picking is not a very profitable occupation, especially by inexperienced hands, and, too, the price for picking is much lower this year than formerly. Considering all these things it would not be surprising to see some of the party wending their way home in a few days by the overland route, limited, with stop-over privileges.

THE BLOOMING BLOOMERS.—Several Oregon City young men, says the Enterprise, met Tuesday evening and effected a preliminary organization of an anti-bloomer society. This agitation of bloomer craze leads the Portland Telegram to make the following pointed remarks: "If the bloomer woman is a fleeting fad, as most of her pulp assailants allege, what is the use of wasting wind and time in denouncing her? A keener knowledge of the feminine temperament would suggest that the best plan of precipitating her retirement would be to utterly ignore her."

A DOUBLE TRAGEDY.—A dispatch from Astoria states that about 5 o'clock Tuesday morning Francis Feakes, the keeper of a small luncheon shop, while in a temporary fit of insanity, it is supposed, fired two shots out of a revolver at his wife, and then deliberately placed the revolver at his right temple and blew the whole top of his skull off. The attention of the neighbors was attracted by the children of the couple, six in number, who escaped from the house by jumping out of the window. When the house was reached Feakes was found dead on the floor, and his wife was unconscious from the effects of two wounds in the head, and the physicians think she cannot recover. It appears that Feakes had chastised one of the children, and Mrs. Feakes, on arriving home in the evening and hearing of the incident, remarked that her husband would have to answer for his conduct in the police court the following day. During the night a wordy war was in progress, but in the morning, as was usual, the husband got up and made coffee. He brought some to his wife's room, and she drank it while sitting on the edge of the bed. She had just finished when her husband remarked: "That's the last coffee you will drink, old woman." He then began shooting. The first shot entered above the left breast, and the second ranged upward under the collar-bone.

SHOULDER DISLOCATED.—County Judge Blanchard is perhaps the most unlucky man in Columbia county. Last Saturday while at work with his pile driver at Kalama a handspike which he was using gave way letting him fall through a hole in the wharf about 13 feet to the rocks below, dislocating his left shoulder, breaking two ribs and seriously bruising his left leg, side and face. He is again able to be about, however, carrying his arm in a sling. About two years ago Judge Blanchard, while engaged at similar work, fractured his leg and dislocated his shoulder, in addition to other injuries from which he has not entirely recovered. The judge is ambitious, however, and notwithstanding his age never gives up. He was here Monday and Tuesday attending to his official duties as a member of the county board of equalization.

THE PORTLAND EXPOSITION.—The Portland Industrial Exposition will open on October 5th, and close on November 5th, 1893, lasting just one month. To the credit of the exposition this year it may be said it will be conducted on a different plan from that of 1894. It is being promoted entirely by the business men of Portland instead of by an imported boomer as last year. The business men of the metropolis have subscribed the sum of \$10,000 to be used to make the big fair a success, and sufficiently attractive to invite inspection by people from all parts of the northwest. The admission this year has been reduced to 25 cents, or just one half the price charged in former years. Mr. Charles H. Dodd is chairman of the exposition committee and Mr. E. C. Masten secretary, which fact, when taken into consideration the business interests of these gentlemen in the northwest, insures success to the enterprise.

OREGON HOPS MUST LEAD.—The hop crop of Oregon is this year far ahead of the crop on the Sound, says the Oregonian, and an old dealer in hops says that, as he has always predicted, Oregon will become the banner state of the coast in the hop line. "Our climatic conditions and soil are such," he continued, "that they cannot be beat. Some roots of the celebrated Bohemian hops have been procured, and are now being cultivated here, and it is expected that within a short time Bohemian hops will be produced in Oregon superior to those produced in Bohemia. It is found that hops can be grown here on high ground as well as in low ground, and of a better quality. Some year before long hops will fetch a high price again, and Oregon hopgrowers will make money galore."

CALL ON THEM.—The "ad" of the Chicago Crockery Store, Portland, appears in this issue, together with prices on a few staple articles. Mr. Bradshaw, one of the proprietors, has some property interests in this county upon which he pays tax, and annually pays a visit to his place. He takes a great deal of interest in Columbia county affairs. Already the firm enjoys a good patronage from this section of the state, but today quote some prices that are away down.

CHICKENS GALORE.—Mr. Thomas Saindon of Deer Island, has engaged extensively in the poultry business this year. He has now 1000 chickens of this year's hatch, most of which are ready for the market. Mr. Saindon is the blacksmith at Deer Island, but owing to the falling off of work in the shop he turned his partial attention to poultry which will, no doubt, net him a handsome sum considering the investment.

THE STATE FAIR.—The Oregon State Fair will be held at Salem, commencing Wednesday, September 25th and continue four days, closing Saturday evening. Great efforts are being put forth by the managers to make the fair a greater success this year than ever before.
