RAILROAD SUPPLEMENTS.

The railroad corporations of the United States are using every means in their power to create public sentiment against President Roosevelt's programme for government control and regulation of common carriers. There is no doubt whatever that they are expending great sums of money for this purpose, and as the work is being carried on under the direction of able men who understand the best methods, they are taking into consideration the small newspapers of the country, and are sending out free supplements to all editors who will make use of them.

THE MORAL WAVE REACHES ASTORIA

There is no stronger testimony to the force of the "moral wave" that is sweeping this country than the fact that it has reached Astoria, and a municipal campaign is to be fought there in which the contestants are either for or against an "open town." We remember, in the days long gone by, that we had an ambition to conduct a newspaper in the city of canneries and visited the place for the purpose of prospecting it with that end in view, but decided that the necessary outlay for being a good fellow in order to secure the patronage of Astoria's leading business men—the saloon and gambling house keepers—would more than balance the income that could be secured.

Speaking about the Mitchell ring, Governor Chamberlain, when he went outside of his own party to appoint a district judge selected Mr. Harris of Eugene, speaker of the House that elected Mr. Mitchell United States Senator, and chief manipulator in the convention that nominated Blinger Herringman for Congress, at Eugene. There always were a large number of Mitchell Democrats, and our Governor appears to have been one of them.

The highest mark ever attained in the production of wealth by farms in the United States was reached in 1905. The total is \$6,415,000,000. Some of the large crops are: Corn, bushels, 2,708,000,000; hay, 4,005,000,000; cotton, 575,000,000; wheat, 452,000,000; oats, 282,000,000; potatoes, 138,000,000; barley, 458,000,000; tobacco 112,000,000; sugar cane and sugar beets, 150,000,000; rice, 81,582,000; dairy products, 466,000,000; poultry products, 450,000,000.

The committee having in charge the proposed amendments to the State constitution has withdrawn the two most objectionable ones—the imperative mandate and majority representation. They realize that the people of the State of Oregon do not favor giving the minority control of the majority.

RAILROAD ASSESSMENTS IN COLUMBIA AND MULTNOMAH COUNTIES.

The county assessor of Multnomah County assessed the railroad corporations at a valuation of \$17,000 per mile upon their roadbeds and the county board of equalization (Republican) sustained the assessment. In making the assessment every foot of sidetrack was included.

The county assessor of Columbia County (Republican) assessed the railroad corporations in Columbia County at a valuation of \$18,000 per mile upon their roadbed, and the county board of equalization (Democratic) reduced his assessment to \$12,000. In making the assessment in this county no sidetracks were counted, so that the valuation in Multnomah was considerably higher than in this county.

The assessment was as follows: Northern Pacific, as assessed by Mr. Laws \$396,000 As reduced by the democratic board 281,600

Loss to the county 114,400 A. & C. as assessed by Mr. Laws \$270,000 As reduced by the democratic board 232,000

Loss to the county 38,000 Total loss of valuation \$152,400

At a three per cent tax for all purposes this would yield a revenue of \$4,672. A very handsome gift to the railroad corporations. Moreover, if the same kind of a board of equalization is continued in control it means a continuing gift of approximately the same amount.

A great howl was raised during the last campaign over the alleged extravagance of the county court, and every little trifle was magnified to secure the election of the opponents of the Republican party. The Mist is and always has been willing to admit that mistakes were made; but what a howl would go up from our friends, the enemy, if a Democratic assessor had fixed the valuation of the railroads in this county at \$18,000 per mile and a Republican board of equalization had cut it down to \$12,000.

How handy that amount would come in building that Nehalem road from Pittsburg to the county seat.
