

Delinquent Tax List 1910

This advertised list of delinquent taxes for the year 1910 is in pursuance of an act of the State Legislature, which is embodied in Chapter 275 of the GENERAL LAWS OF THE 1911 SESSION.

The taxes on the following advertised real property became delinquent on the Fourth day of April, 1911, and are subject to a penalty of 10 per cent and interest at the rate of 12 per cent per annum until they shall have been paid.

Any day after the expiration of six months after the taxes charged against the following real property are delinquent, the Sheriff is authorized to issue, to any one applying therefor, a certificate of delinquency upon payment of the taxes, penalty, interest and cost of advertising.

Certificates of delinquency shall bear interest from the date of issuance until redeemed at a rate not exceeding 15 per cent per annum.
