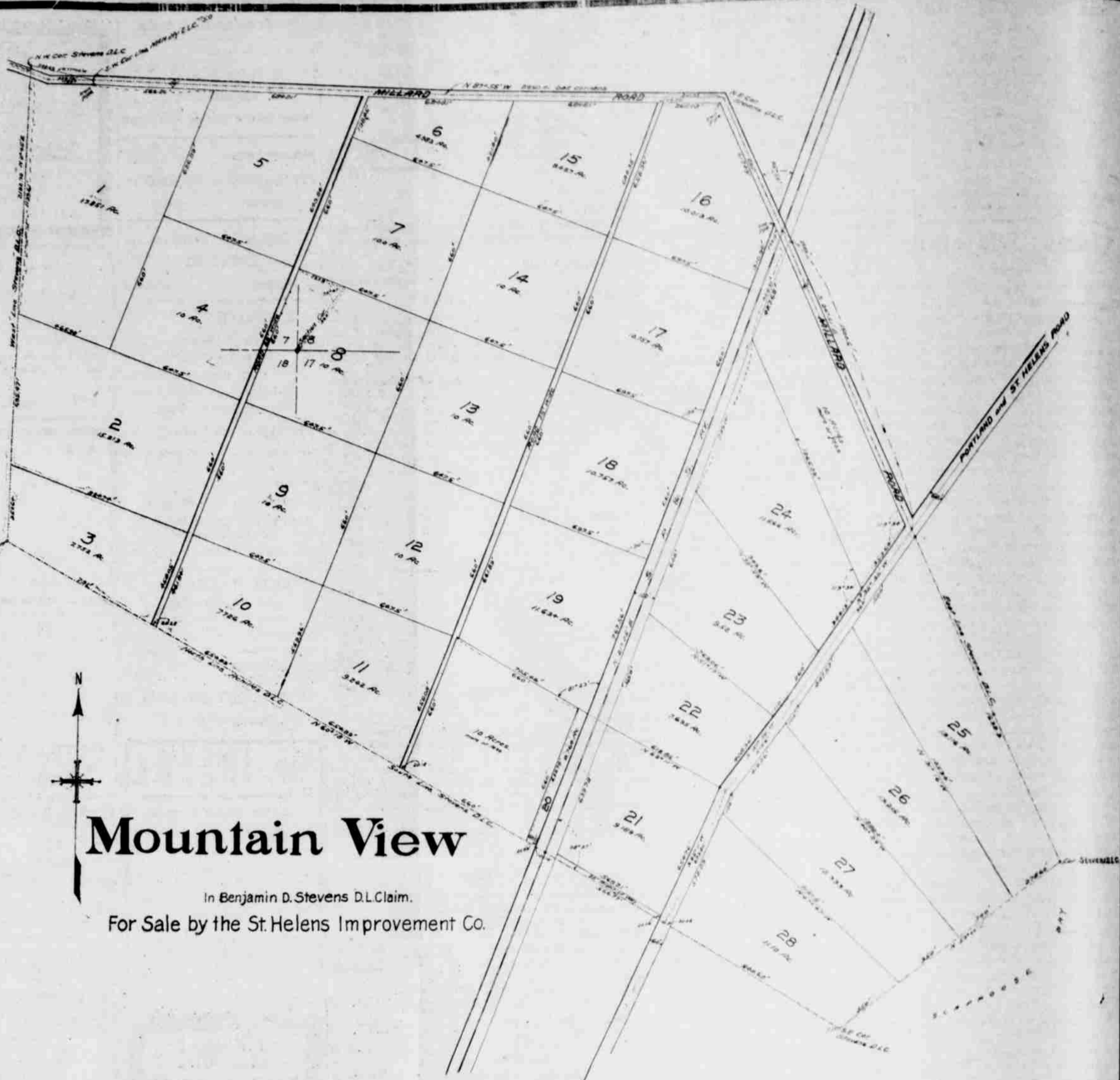

### SUMMONS

In the Circuit Court of the State of Oregon, for the County of Columbia. Carrie B. Morrow, Plaintiff.

To the above named defendant, G. H. Morrow.

In the name of the State of Oregon, you are hereby required to appear and answer the complaint filed against you in the above entitled court and cause on or before the 7th day of June 1912, that being the date fixed by the court for you to appear and answer herein and being six weeks from the first publication of the summons, in default whereof, plaintiff will apply to the court for the relief demanded in the complaint, to-wit: For a decree of divorce dissolving the marriage contract now existing between plaintiff and defendant on the grounds of cruel and inhuman treatment, and for such other and further relief as this court may deem equitable.
