Ordinance No. 128

An Ordinance providing for the installation of a sewer, in Sewer District No. 2, in the City of St. Helens, Oregon, embracing and including all of the following described territory to-wit: All of Blocks 2, 13, 16, 28, 31, 32, 33, 34, 41, 42, 43, 48, 49 and 57; and all of Lots 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16 and 17, in Block 17; all of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19, in Block 27; all of Lots 1, 2, 3, 4, 5, 6, 7, 8, 13, 14, 15, 16, 17, 18, 19, 20, 21 and 22, in Block 58; all of Lots 4, 5, 6, 7, 15, 16, 17, 18, 19, 20, 21 and 22, in Block 65; all of Lots 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19 and 20, in Block 50; all of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19, in Block 66; and all of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19, in Block 65; all in the City of St. Helens, Oregon, in pursuance of the ordained declaration of the Common Council of said City; empowering the Common Council of said City to contract for such installation; providing for the payment thereof by the property owners within said District; constituting the assessed charge on each lot in said District a lien thereon until paid; providing for the drawing of warrants in payment of said improvement; providing for a lien docket; providing for the issuance of certificates of delinquency and the foreclosure of the same; and empowering the Common Council, generally, to pass any and all needful ordinances for the collection of such assessment, should at any time this ordinance be found insufficient.

Whereas, in accordance with Ordinance No. 126, duly passed by the Common Council of the City of St. Helens, Oregon, on the 15th day of July A. D. 1912, and on said day duly approved by the Mayor of said City, due and legal notice was given to the real property owners of said Sewer District No. 2, of said City, of the time and place of a meeting, at which time and place they, or any of them, might make and file objections, if any they had, to such improvement;

And Whereas, said meeting was had and was fully attended, and no remonstrance or objection of any kind was made, filed or raised to said improvement so contemplated, or to the boundaries of said District, except that it was contended by W. B. Dillard that the lateral to run into what is known as Dillard's lake occupying a portion of the ends of Blocks 48 and 49 in said City, should be constructed directly along St. Helens street and not diagonally across blocks 43 and 48, as contemplated, which demand was conceded to be reasonable and such change ordered to be made, with the additional change that said lateral be constructed of eight inch material in place of six inch as shown on the plans;

And Whereas, the plans and the specifications, as heretofore, to-wit, on the 19th day of June 1912, filed herein, with the changes above noted, have been formally adopted;

And Whereas, E. E. Quick, P. W. Harrison and A. W. Moeller, the duly appointed arbitrators and appraisers in said matter, have made an equitable apportionment of the probable cost of said sewerage system, among the real estate owners of said Sewer District, basing said estimate upon the last preceding assessment of real property only;

And Whereas, all and every matter and thing, as a condition precedent to the right to construct said sewer, and assess the real property within said District therefor, has been performed;

Now, Therefore, the City of St. Helens does ordain as follows:

Section 1. That the Common Council of the City of St. Helens, Oregon, is hereby authorized and empowered to install a sewerage system in Sewer District No. 2, of said City, embracing and including all of the following described territory within the limits of said City, to-wit: All of Blocks 2, 13, 16, 28, 31, 32, 33, 34, 41, 42, 43, 48, 49 and 57; and all of Lots 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19, in Block 17; all of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19, in Block 27; all of Lots 1, 2, 3, 4, 5, 6, 7, 8, 13, 14, 15, 16, 17, 18, 19, 20, 21 and 22, in Block 58; all of Lots 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19 and 20, in Block 65; all of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19, in Block 66; and all of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19, in Block 65; all in the City of St. Helens, Oregon, in accordance with the intention of said Council as declared by Ordinance No. 126, of said City, and to that end that the Recorder of said City be, and he hereby is, required to advertise for the period of two weeks in a newspaper of general circulation, published weekly, in said City of St. Helens, and also for three issues in a newspaper of general circulation published daily, in the City of Portland, Oregon, for sealed bids for the furnishing of all material and labor necessary for the construction and installation of such sewerage system, in accordance with the plans, profiles and specifications thereof, filed with the Recorder of said City, on the 19th day of June A. D. 1912. The notice for bids shall provide for a certified check in the sum of ten per cent of the bid, running to the Mayor of the City, and shall further provide that the said Council will reserve the right to reject any and all bids should they be deemed disadvantageous to the City;

Section 2. That the contractor whose bid shall be accepted, shall be required to enter into a formal contract with said

City for the prosecution and completion of such work, and he shall execute the usual bond and with good and sufficient surety with the additional obligations that such contractor or contractors shall promptly make payments to all persons supplying him or them labor or materials for any prosecution of the work provided for in such contract;

Section 3.—That for the purpose of such improvement and to provide means for the payment of the same, the appraisers shall as soon as the actual cost has been ascertained, assess all of the real property, within said Sewer District No. 2, above described, such assessment to be determined by an equitable apportionment of such real property among all the real estate owners in said Sewer District, based upon the last preceding county assessment of real estate only, and not upon the improvements thereon; and the costs and expense of making such improvements shall be a charge against and a lien upon the property within said Sewer District in accordance with such apportionment;

Section 4. That as soon as such apportionment has been made the Recorder of said City shall enter in a docket for that purpose, by name or number, a description of each lot or parcel of land against which said assessment is made, with the name of the owner or owners, and the amount of the unpaid assessment. Such docket shall stand thereafter as a lien docket as for taxes assessed and levied in favor of said City, and for the amounts of such unpaid assessments therein docketed, with interest on said unpaid assessments at the rate of six per cent per annum against such lot or parcel of land, until such assessments and interest are paid; and all assessments and interest shall be and remain a lien on each lot or parcel of land respectively, in favor of said City, and have priority over all other liens and incumbrances whatever;

Section 5. That whenever any payment of installments, interest or costs shall be made under the provisions of this ordinance, the Recorder of said City shall make an entry thereof in said docket, with the date of the same; and such payments made and entered in said docket shall operate as a discharge of said lien to the amount of such payment and from the date thereof;

Section 6. That the Common Council of said City is hereby authorized to issue warrants, based upon the credit of said Sewer District No. 2, of said City, to be known as Sewerage District Warrants of Sewer District No. 2, bearing interest at the rate of six per cent per annum interest payable annually, which said warrants shall be accepted at par and issued from time to time as required to defray the expense of putting in said sewerage system;

Section 7. That said warrants shall be drawn in such form and denominated that the said taxes or any part thereof, when collected, may be made immediately applicable to the payment of some portion of said warrants, and final payment shall not in any instance extend beyond the period of ten years;

Section 8. That as soon as the appraisers shall have made the assessment provided for in Section 3 of this ordinance, the Common Council of said City shall publish notice of such assessment for three successive weeks in a newspaper published in said City, requiring all persons owning property in said sewer district so assessed for such improvement in the sum of \$25.00 or more, at any time within twenty days from the date of the first publication of such notice, to file with the recorder of said City, a written application to pay said assessment in installments; such application shall state that the said applicant and property owner does hereby waive all irregularities or defects, jurisdictional or otherwise, in the proceedings to make such improvements for which said assessment is levied and in the apportionment of the cost thereof. Said application shall contain a provision that the said applicant and property owner agrees to pay said assessment in ten equal annual installments, with interest at the rate of six per cent per annum, payable annually;

Section 9. That the applications so received shall be entered in a book kept for that purpose, showing the date of filing each application, the name of the applicant, a description of the property, and the amount of the assessment;

Section 10. That thereafter there shall be due and payable annually for ten successive years to the recorder of said City, by the owner of each lot or parcel of land assessed for the said sewer improvement whose application to pay the cost of such sewer by installments has been filed as herein provided ten per cent of the cost of said sewer assessed against the property of such owner, as appears by said lien docket, with the amount of one year's interest at six per cent per annum on all unpaid assessments or installments. That first payment aforesaid, shall be due and payable at the expiration of one year from date of the said assessment in the lien docket aforesaid, and subsequent payments at the expiration of each year thereafter. Should such owner or owners neglect or refuse to pay the same or some aforesaid as the same shall become due and payable for a period of twenty days, then the same shall be deemed delinquent, and the recorder shall have the right, and it shall be his duty, upon demand and payment of the installment, penalty and interest, to make out a certificate or certificates of delinquency against such property, and such certificate or certificates shall be numbered and have as tub, which shall be a summary of the certificates and shall contain a statement:

1. The name and residence of the person to whom issued;

2. Description of the property assessed;

3. Year or years for which assessed;

4. Amount of assessment and interest due;

5. Name of person to whom assessed;

6. The rate of interest the certificate shall bear;

7. The time when a deed may be had, if not sooner elapsed;

8. When a certificate of any preceding year is outstanding and unreleased it shall be stated in subsequent certificates issued, and the principal sum due with date of issue.

Any number of lots or parcels of land assessed to the same person, or as the property of an unknown owner, may be included in one certificate;

Section 11. That said certificates of delinquency shall bear interest from the date of issuance until redeemed at the rate of ten per cent per annum, and shall be sold and issued to any person in the order of priority in applying therefor upon the payment of the value in principal and interest thereof; and such certificates shall be sold, redeemed and foreclosed in conformity with the provisions of Chapter VIII of Title XXVIII, of Lord's Oregon Laws, for the collection of taxes, and the method of the proceedings on foreclosure thereof and the issuance, service and return of summons, and the manner and time of making deeds under such proceedings and all matters and things necessary to be had or pursued in order to fully carry out the purposes hereof, including the right of appeal and the Courts in which such proceedings shall be had, shall be as prescribed by said Chapter VIII, except that all certificates of delinquency shall be issued by the Recorder, all redemptions made by him and the order for the sale of any such real property made by the Court, shall be directed and delivered to the City Marshal in place of the Sheriff, who shall thereafter act in all things connected therewith instead of the sheriff.

Section 12. That all assessments against any property in said sewer district for which no application has been made or allowed for the purpose of paying the same by installments, shall be due as soon as made, and shall be delinquent from and after the expiration of three months from the date of the said assessment in the lien docket aforesaid; and thereafter the same proceedings shall be had for the collection of said assessments, issuance of delinquency certificates, foreclosure of same, sale of property, issuance of deeds, etc., as are herein provided for assessments payable in installments;

Section 13. That the common council of said City are hereby empowered to enact any and all additional or supplemental ordinances necessary to fully and completely carry into effect the intent and purpose of this ordinance.
