FAIR HOUSING LAWS

CARE HOUSING LAWSThe Federal Fair Housing Act prohibits discrimination in the sale, rental, leasing and financing of housing, as well as discriminatory advertising, on the basis of RACE, SEX, COLOR, RELIGION, NATIONAL ORIGIN, MENTAL or PHYSICAL HANDICAP, or FAMILIAL STATUS. In addition to these categories, the State of Oregon also prohibits discrimination based on MARITAL STATUS. (Our local jurisdictions also have specific applicable regulations)."
These laws cover any potential or actual sale, lease, rental, eviction, price, terms, privileges or any service in relation to the sale of or us of housing. The not only prohibit advertisements which clearly restrict access to housing based on the protected categories, but also prohibit advertisements which indicate a preference for or against a person based on a protected category. In particular circumstances, use of undicate a discriminatory preference."

Such advertisements should be referred to a supervisor for consideration and determination. Such claims are irrelevant for purposes to the advertisement published in this newspaper. Every housing advertisement published in this newspaper is subject to the Fair Housing laws.
