## **Project to replace Silverton Road bridge postponed**

A project to replace the bridge on Silverton Road over the Little Pudding River has been pushed back to spring of 2021.

Additional studies to complete the right-ofprocess have way prompted the county to push back the start of construction, according to Marion County Public Works officials.

The project will close Silverton Road between 60th Avenue and 64th Place to replace the bridge along the existing alignment.

Two other options to build adjacent to the existing bridge, which would have left Silverton Road open during construction, were decided against due to increased costs and impact to the neighboring properties.

The new bridge will be raised to better match the roadway approaching and include two lanes plus a center turn lane extending to 64th Place.

The \$6.4 million project is expected to go out for bid in February 2021, begin construction in spring and be completed by Thanksgiving. The project is being paid for with federal-aid funds and a 10% match by the county.

SUMMARY: The RBS has made a Finding of No Significant Impact (FONSI) with respect to a request for possible financing assistance to Bighorn Solar, LLC for the construction of a 2.2 megawatt (MW)solar Facility in Marion County, Oregon.

The Project would have a generating capacity of 4,064 megawatt-hours (MWh) of energy per year and would sell this energy to Portland General Electric (PGE) under a longterm fixed power purchase agreement. When constructed, the solar arrays and associated components would be no more than 10 feet in height and would be surrounded by 7-foot tall chain link security fence. The facility will be located on privately-owned property in Marion County, Oregon.

Grants

Most are still liable for building and equipment rental fees. Financial hurt is widespread.

"It's an unprecedented flipping of the economic switch to 'off," said Fischer, a financial planner. "At some point, the switch will be flipped on again, but the hope, with this fund, is that we can bridge the gap until then. Once businesses can get their doors open again and get going, then they're going to be okay."

"This is the moment when we have to figure out how important it is for us to protect our local economy," said Mayor Kyle Palmer, a member of fund's committee.

While Palmer and other committee members recommend that business owners apply for fi-

nancial aid from the government (Marion County's CARES Act fund is one example), they want to help businesses avoid falling through the cracks or closing because they can't get aid fast enough.

Some firms can't apply for government aid because they are too new, while others don't qualify because they have "more than five employees," Fischer said. It's these kinds of businesses that could benefit from a local alternative. In a small town like Silverton, applications can be viewed case-by-case rather than categorically denied.

For some Rotary Club members, the motivation for pivoting from the usual agenda to shore up local livelihoods is the endowment fund itself, built to self-sustenance in 1990s by generous contributions from Silverton businesses.

"We compiled funds because of these businesses, so now it's just us returning the favor. It's really just giving back," Fischer said.
