**DAVIS' FIGURES**  
 In his address responsive to the formal notification of his nomination to the high office of Vice President, the Hon. Henry G. Davis, at White Sulphur Springs, W. Va., on August 17, made the following statement. Quoted from the Portland Journal, the leading democratic paper in Oregon:  
 "Our republican friends are prone to refer to the commercial growth of the country under their rule, and yet the census reports show from 1850 to 1880—under democratic rule and Walker tariff—percentage of increase, a greater population, wealth, manufactures and railroad mileage, factors which affect most largely the prosperity of the country than in any decade since."  
 Without stopping to justify with per cents, the Census will give the figures—they appear on the books of the U. S. treasury, and let our readers do their own figuring. The U. S. census for 1850 placed the population of the United States at 23,191,876, and that in 1880 gave 31,143,321, a gain in the decade of 8,251,445.  
 The census of 1890 placed the population of the United States at 62,822,250 and in 1900 at 76,303,327, a gain in the decade of 13,681,137.

Following Senator Davis in the order he presented the subjects we find that in 1850 the aggregate wealth of the people in the United States was \$7,135,786.00, in which was included the value of 3,212,213 slaves, which at the low estimate of \$100 per slave would be \$320,413,300. The aggregate wealth of the people of the United States in 1860, including the value of 3,953,760 slaves, was \$16,159,616,000, a gain during the decade of \$9,023,830,000.

The per capita wealth of the people in 1850 was \$307.69 and in 1860 \$513.93.  
 The aggregate wealth of the people of the United States in 1890 was \$65,037,900, a little over four times what it was in 1860. In 1900 the aggregate wealth was \$94,300,000,000 dollars. The gain in wealth in the decade from 1890 to 1900 was \$29,262,900,000.

Let us see how Senator Davis' general assumption that manufacturing developed faster in the last decade of democratic rule from 1850 to 1860, than during any decade of republican rule, stands the test of inspection of the records. In 1850 there were 123,025 establishments in the United States engaged in manufacturing that gave employment to 957,059 persons to whom were paid in salaries and wages \$236,755,404, an average of \$247.38.

In 1860 there were 140,433 manufacturers in the United States with an average number of employees of 1,911,246, to whom were paid in salaries the sum of \$378,878,966. The gain in number of factories for the decade between 1850 and 1860 was 17,408; the number of employees increased by 354,187; amount paid for labor in-

creased by \$142,123,502 and value of output increased \$865,753,160.

The above is not a bad showing, and without stopping to consider the effect that the Crimean war and the Pacific Coast gold output had upon the business affairs in the United States during the last decade of democratic rule, which had then extended for fifty years, let us jump the civil war and take some figures from the decade of Republican rule from 1890 to 1900 and see how they compare with the decade Senator Davis selected for comparison. In 1890 there were 355,415 manufacturing establishments in the United States that gave employment to 5,712,622 employees, to whom were paid in wages and salaries \$2,283,216,520 and turned out products to the value of \$9,372,437,283. In 1900 there were 512,734 manufacturing establishments in the United States that employed 5,719,137 operators, to whom were paid in salaries and wages \$2,735,439,848 and products to the value of \$13,039,279,566 were turned out.

The miles of railroad operated increased from 1850 to 860 from 9,021 to 30,626. In 1890 there were 166,654 miles of railroad in operation in the United States and in 1900 there were 194,324.
