Ahtiche xiv.
"Section 1. All persons bot or naturalized in the Unitc States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they resid. No Saste shull make or eufuree nty privileges or immunities of citizens of the United States; nor son of life, liberty or property, without due process of law, nor deny to any person within its urisdictioa the equal pratection the laws.
"Section 2. Representatives shall be apportioned among tha several States accordivg is their
respective uumbers, counting the whole number of persons in each State, excluding Indians not tuxed. But when the right to vote at any election for the
choice of electors for Previdens and Vice President of he Unit
Sitates, representatives in Con gress, the executivo and judicisl officers of a State, or tho memthers of the Legislature
thereot, is denied to any of the thereoi, is denied to any of the
maie onhabitants of such State heing twenty one years of age,
