Blue Mountain Grange Meeting

Rousing Meeting, Large Attendance and Many Resolutions Were Adopted--The Next Meeting.

Grange Hall Dec 3

Resolution adopted by Blue Mountain Grange No 345.

Whereas—There is considerable agitation in some of the leading newspapers of the state and among politicians and especially among men interested in the liquor traffic in favor of repealing or radically amending the Local Option law adopted by the legal voters of the state at the last June election. By the Legislature at next session.

And also to take like action with regard to the primary election law thus nullifying the initiative and referendum amendment to the state constitution.

Therefore we members of Blue Mountain Grange of Union County do most earnestly protest against the legislature of the state repealing or in any way amending any law that as or may be adopted by the legal voters of this state through the Initiative and Referendum.

And we earnestly request all other granges of this state to take similar action to the end that notice be served on the Legislature that the people are jealous of their rights.

Also a resolution was adopted by the grange giving their approval and approbation to the electric railway through the country.

Resolved by Blue Mountain Grange No 545 Union Co Oregon. That we are opposed to the state of Oregon incurring the expense of building the Portage Railroad at the Dalles of the Columbia River for the reason that we do not believe that the benefits to

be derived by such building will justify heavy expenditure necessary to build the same.

In fact we entertain very grave doubts whether said road will be of any practical benefits to the region of country which it is expected to serve. We believe that the ship canal which the Federal Government proposes to build is the only means of material improvement in transportation facilities for the country interested in said improvement.

Therefore we recommend that the Oregon Legislature at its next session repeal the act appropriating \$165,000 for said Portage Railway.

He died about one hour after taking the acid.

A few months ago McIlwain married Leona Cameron of this city.

Brooding over family as well as financial troubles is supposed to have caused McIlwain to become despondent and that he was temporarily insane when he committed the deed.

COST OF LIVING IN UNITED STATES

So much random talk is indulged in by parties interested proving their pet theories or economical questions and social problems as to the cost of the necessities of life in the United States that the Observer, not wishing to be misled by assumptions and guesses, concluded to find out, if possible, the actual facts. In its search for facts it procured from the United States Commissioner of Labor, his Eighteenth Annual Report, which is a bound volume of 865 pages giving the figures as to the actual cost of living in the United States in the year 1903, which book was received this Thursday morning direct from Washington. It presents the result of an investigation as to cost of living for one year, 1903, of 25,440, representing 124,108 persons, in the United States, residents in nearly every state in the Union.
