The work of grading the first 22 miles of the Spokane & Inland railway (electric) has been let to Porter Bros. of Spokane, to be completed within three months.

Steel rails, piles, lumber and rock to the value of \$98,000 have just been contracted for at Portland, the same to be used in the jettying the mouth of the Columbia

The Grand Trunk railway sought a land grant of 15,000 acres to the mile from the coast eastward through British Columbia, and that government flatly refuses to grant the subsidy.
