The appointment of a supervisor for R D 11, was awarded to Henry Rinehart.

The petition of the Ibez Land Co for compromise of taxes was granted.

In the matter of the road petitioned for by B F Harrell et al it was ordered that the board of County Road Viewers meet at said proposed road and view and layout said road as by law directed.

The resignation of E V Davis as supervisor of R D No 26 was accepted.

Jesse Spencer was appointed supervisor of R D No 26.

The petition of Clark E Saunders, M D, asking for his appointment as secretary of the Union county board of health was granted, and Clark E Saunders M D, was elected as secretary of the Union county Board of Health, at a salary of \$100.00 per annum.

The bond of J R Elmer as supervisor of R D No 17 was approved.

In the matter of the petition of the Home Fruit Growers Association for an additional appropriation for the Lewis and Clark Exposition, ordered that the Clerk draw a warrant on the Contingent in favor of the La Grande Commercial Club for \$500.00.

The petition of A S Brown for a return of money paid on the 1903 roll was denied.

The resignation of G D Tucker as supervisor of R D No 5 was accepted. Ira Stewart was appointed supervisor of R D No 5.

The petition for a settlement of taxes for the years 1898-1899 & 1900 on property assessed to the La Grande Real Estate Association was continued for the term.

In the matter of the County Road petitioned for by Dillie Randall et al, it was ordered that the Board of Road Viewers lay out said road as by law required.

In the matter of the County Road petitioned for by D McDonald et al. It was ordered that said road be opened for travel upon the payment to the Clerk of \$25.00.

In the matter of the appointment of three commissioners for the First Eastern Oregon District Agricultural Society, W G Hunter, W I Disham and Hon P A McDonald were appointed.

In the matter of the appointment of a County Fruit Inspector, A I Gale of Union, Oregon was appointed.

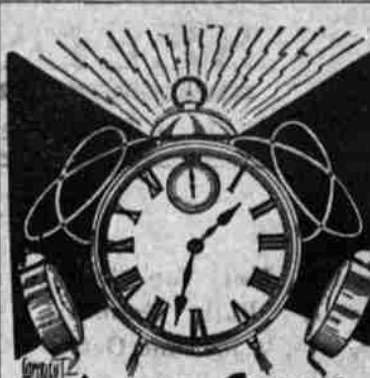
