The fact that President Roose velt is now enroute to New Orleans adds interest to the yellow fever situation there On Sunday the 15th there were 9 new cases and 3 deaths. The number of cases up to 6 p m Oct 15 totaled 3.314, of these 431 died, 2,740 discharged as eured leaving 143 in hospitals under treatment. The death rate of those having the disease was 13 per cent. The per cent of patients discharged was a little over 8267 per cent of those sent to hospitals with yellow fever 4.33 per cent stricken were yet in hospitals, while the head lines to the yellow fever news have all along announced that the disease was under control the figures do not substantiate the hope.
