PROCLAMATION

Whereas, the Secretary of State of the State of Oregon has notified me in writing that pursuant to the provisions of an act entitled "An act making effective the initiative and referendum provisions of Section 1 of Article IV of the Constitution of the State of Oregon..."

Now, Therefore, I, Geo. E. Chamberlain, Governor of the State of Oregon, in obedience to the provisions of said act herein before first mentioned do hereby make and issue this Proclamation to the people of the State of Oregon...

Section 2. Corporations may be formed under general laws, but shall not be created by the legislative assembly by special laws. The legislative assembly shall not enact, amend or repeal any charter or act of incorporation for any municipality, city or town.

Done at the Capitol at Salem, this 28th day of February, A. D., 1906. (Signed) Geo. E. Chamberlain, Governor.
