## A TOY PISTOL VICTIM

The deadly toy pistol reaped its first victim Sunday in the death of eight-year-old Johnny Wiley, living at 1907 Ninth street.

The boy was playing with the death bringing toy about a week ago at his home when in discharging the cap he received a wound in his hand and lockjaw rapidly developed. The boy was taken to St. Elizabeth hospital where all efforts to save him from the deadly tetanus were in vain. Death came about 5 o'clock Sunday morning.

The pistol, the instrument of death, was one of those small affairs made to shoot blank cartridges, with one of these in his gun the child was playing. In shooting the pistol he received the discharge in the palm of his left hand.

The funeral occurred this afternoon at 3 o'clock at the family residence, Rev. Finger of the M. E. Church officiating. Interment was made in Mt. Hope cemetery.

Dr. Parker, who attended the patient says that symptoms of lock-jaw were noticeable last Friday night, about a week after the accident, and he telegraphed at once to Portland for certain medicines which arrived yesterday morning a couple of hours after the boy had died. Dr. Parker says the discharge of the toy pistol was directly responsible for the death of the little boy and he says parents should be mighty careful about letting their children play with these instruments. This is the second case of lock-jaw which has come under Dr. Parker's notice since his residence on the Pacific coast.—Baker City Herald.
