SECRETARY METCALF IS ON HIS WAY TO SAN FRANCISCO TO INVESTIGATE CHARGES

ENGLAND IN DOUBT OF TREATY RIGHTS

May be Involved in Case of a War Between America and Japan Parliament Will Consider Monday

(Scripps News Association)

London, Oct. 27.—Parliament on Monday will consider the troubles between Japan and America arising from the exclusion of Japanese from the schools of San Francisco. The situation is so serious that Great Britain considers the subject worthy of Parliamentary inquiry. Fears are entertained that England might be involved in war should there be a break between the two countries, under the terms of treaty between Japan and England. Upon this point, inquiry is to be directed to the Foreign secretary.

METCALF ENROUTE FOR FRISCO
Washington, Oct. 27.—Secretary of Commerce and Labor, today left for San Francisco to investigate the Japan situation there and report to the President.

Before leaving the secretary lunched with the President and they decided at length Metcalf's mission to California, regarding the Japanese trouble and he expects to remain in California several weeks. As the secretary is a citizen of the Golden state and understands the conditions after being on the ground personally he will soon be able to get to the bottom and general feeling of the people.

MAYOR SCHMITZ INTERVIEW
London, Oct. 27.—Mayor Schmitz, of San Francisco, stated this morning while discussing the recent evidence of friction between the United States and Japan, that the system of co-education in San

Francisco is responsible for the controversy between the two nations.

He went on to state that it stands to reason that in a city like San Francisco, the most cosmopolitan in the world, that it is imprudent, not to say immoral, to educate foreigners side by side with native born Americans. He says that he thinks the matter has been exaggerated, and that Japan will ultimately see that the action barring the Japanese from the schools is for the best.

Mayor Schmitz says that he has nothing against the Asiatics, but does not think it is right for male and female children to mix especially when girls are in excess. He says the expulsion of the Japanese boy Yasumare was not an evidence of prejudice but simply a desire to do right on the part of the officials of the institute.

SCHOOL BOARD FIRM
San Francisco, Oct. 27.—The secretary of the school board announced today that the board has no intention of modifying its action in the matter of the exclusion of the Japanese children from the public schools, despite the representation of the Japanese government to President Roosevelt. The board says the Washington authorities are misinformed and contends that the board has the right under the state law to maintain separate schools for the Mongolians.

JAPAN UNDERSTANDS
Washington, Oct. 27.—It is understood that Secretary Root has assured the Jap-

anese ambassador Aoki, that the whole trouble is caused by politics and promises that it will all blow over after the November election. Aoki says that his government understands this very well, but intimates that the Japanese government must make a show of resentment to curry favor with their common people.

IN OUR GOOD FAITH

Tokio, Oct. 27.—The Mikado's government is exhorting the nation to be calm and expresses itself believing the assurances from Washington are in good faith.

MRS. SNYDER TELLS ALL ABOUT IT

Hubbard, Ore., Oct. 27.—Mrs. Snyder, widow of Cary M. Snyder, the millionaire of Kansas City, whose remains were discovered near this place, today told the full story of her husband's career. She stated that Snyder with George Perry of Independence, Mo., and a man called Rogers, had plotted to murder the proprietor of a Portland pawnshop and then rob the shop and also the robbery of a Portland theatre. They failed to carry out their plans regarding these robberies and then planned the Forest Grove bank robbery, but the parties quarreled and Snyder did not participate in the bank holdup. She stated that the dynamite which was to be used in blowing up the bank was buried near their home. She says that her husband left home to demand his share of the loot, and has never been seen again. She accuses his companions of murdering him. She was accompanied by her son.

PRESIDENT CELEBRATES BIRTHDAY ANNIVERSARY

Washington D. C., Oct. 27.—The President is forty-seven years of age today. His anniversary was observed in this city by the Hungarian Republican club of New York. A small army of friends also called upon the president and many fraternal offerings. The Hungarians were headed by their president, Marcus Braun, who with his wife and daughter also called at the White House early in the day. The President made a short speech and presented Miss Braun with an American Beauty Rose.

The President's grandfather, Cornelius Van Schaak Roosevelt was a successful merchant and glass importer and laid the foundations of the Roosevelt fortunes.

Theodore was a delicate boy and was not sent to the public schools. He was tutored at home and for a while attended Cutlers school. In 1875 when the family was living in Fifty Seventh St., he entered Harvard and for several years was but rarely in this city.

Some years ago the Roosevelt, growing reminiscent of his enterances into politics, observed "I have always believed, and do not see that a man should join a political organization and should attend the Primaries; that he should, and content to be governed but do his part of his work."

So, upon leaving college I went to the local headquarters, attended all meetings and took my part in whatever was up. There came a revolt against the member of assembly from that district. I was nominated to succeed him and was elected. He was re-elected to the Legislature in 1885 and his activity there as a reformer and anti-machine man is well known.

THE KAISER PROPOSS CHEERS
Berlin Oct. 27.—Led by the Kaiser of Germany himself, these cheers were given for President Roosevelt who is today celebrating the anniversary of his 47th birthday. The opening cheer immediately preceded the inaugural address by Prof. Burgess of the American Columbian university, who is the first man to occupy the Roosevelt chair that has been established in the university of Berlin, by James Speyer. A letter from President Roosevelt was read to the assembly. An address by the Kaiser ended the program.

TWO DAYS TRUCE HENEY IS BUSY

Sensational Arrests Are Expected This Evening—Legal Battle Deferred Until Next Monday

San Francisco Oct. 27.—The warring forces in the struggle for district attorneyship, are working under a two days' truce, and there will apparently be no steps taken in a legal nature until they meet in the court room next Monday, but it is not unlikely that today will bring forth sensational developments. District Attorney Langdon of this county, who is the object of Boss Abe Rueff's attack, held a long conference with Francis J. Heney, the Oregon land fraud prosecutor, who made himself famous this summer in for this work there, and who was called here to assist District Attorney Langdon in his fight against the alleged grafting. Heney appeared in the attorney's office early this morning and is busily engaged in getting his evidence in shape. There was no effort made to keep him out of

the office with the district attorney recognized Langdon as the proper office to talk. The four officers who yesterday guarded the office against the anticipated rush by Rueffites are again on duty today. Attorney General Webb, who has been so severely criticized for injecting himself into the case on the suspicion that he was a friend of Rueff, made a statement today that he would interfere in the case, which is his right under the constitution, only on a contingency of Rueff's contention being upheld that he is the district attorney.

It is rumored in official and political circles that today warrants would be issued for the arrest of certain people against whom strong charges of corruption have been made and that a number of leading officials will be in jail before night.

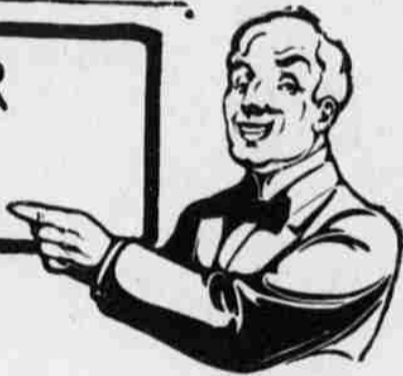
