It is simple and costs near nothing and very little labor, and is a sure and dead shot to the moth:

> Take a tin can. 10x12 or 12x16, eight or ten inches deep, or a coal oil can cut off will answer, paint the bottom of it with some black paint, and when dry fil up to about 4 inches with clear water and put it out under an apple tree and you have a trap that will catch every codling moth that will come near it.

The idea is this: In painting the bottom of the can you form something like a mirror and they see the leaves and limbs of the tree and drop in it and never get out. caught hundreds and hundreds of them. genuine codling moths.
