This is me of the best musical tr-institutions in the state, and that people in this ofly and valley are beginning to discover the attentage of this school. The system is the latest and most practical, and in-cludes at the atest decovers in the art of teaching music. The school is divided into two depart-ments No. 1 is for bightness from 6 years or more and pre taight the first three grades. Public came one hour each day. This is no kin-dergarten system but far superior in No. 2 the grades are from 3 to 15. Here they graduate. Pupils take one or two lessons a week as they deare.
