TEAM HERE FOR GAME

Under charge of Physical Director A. W. Clow and Manager William Steele, the Walla Walla high school basketball team arrived in La Grande last evening to get acclimated and rested up before the game tonight with the Gobblers at the Noyes rink. The squad is a likely looking aggregation and with several splendid records to their credit, will give the locals a little race. The visitors will line up as follows: Bollerman and William Steele, guards; T. Steele, center; Blackman and Douglas, forwards; Utility men—D. Hennessey, guard, and Crawford, forward. Mr. Clow will referee the game this evening.

For the locals, the line-up is not yet definitely decided upon. McKennon has been disabled through an accident. He was kicked on the knee yesterday by a horse, and is in bad condition. Whether or not he can stay the game out, or even open it, remains to be seen. Don Scott will take his place at center in the event that he goes out, and thus is left a weak spot in the guarding, as Scott is one of the fastest in that department of the game, that La Grande possesses. However, Captain Childers and Caylor will be seen at forward, and Fred Young at one of the guards. Hutchinson or Warren may possibly substitute at guard if Scott steps to the center ring.

Basketball spirit has been more or less revived since the Garden City boys reached the city, and the management has picked up additional hope in securing an expense-paying crowd. The game starts at 8 o'clock this evening.

The visitors spent the morning in acquainting themselves with the floor at the rink, and this afternoon visited the high school, where the debate on local option was in progress.

ROAD OPEN MARCH 15.

North Bank Officials Say Passengers, Freight and Mail Will Move Then.

Trains carrying passengers, freight and the United States mails will be whirling along the line of the Spokane Portland & Seattle, commonly called the North Bank road, on March 15.

As required by law, President Francis B. Clarke, of the North Bank, notified the Interstate commerce commission February 15 that his line will be ready for operation on the date given. The government requires the commission to receive 29 days' notice before a new railway line is to be formally opened for business.

Word has also been sent the local postoffice officials that March 15 the North Bank road will be ready to undertake the work of carrying the United States mails. As the mail route in southern Washington and along the Columbia river in Oregon will be practically revolutionized by the new system, which will prevail when the North Bank road is in operation, the heads of the railway mail service are reported to be hard at work now mapping out routes in anticipation of the change.—The Dalles Chronicle.
