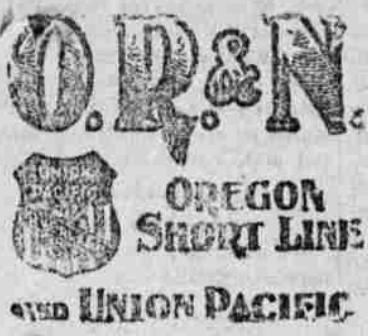

ATTEMPTS SUICIDE.

La Grande Girl at Aid School, Attempts Suicide With Acid.

Tired of living and disappointed because she was not permitted to keep an engagement with some young people, Bessie Palmer, a 16-year-old charge of the Boys' and Girls' Aid society, who had been placed in the home of a well to do family in Irvington, attempted suicide by taking carbolic acid Monday night while in a hysterical fit.

The bottle containing the poison that the girl attempted to swallow, was found by her in a closet. She had asked permission to go out after supper to join some companions and soon after it had been denied, the people in the house were aroused by a commotion in this closet where they found the girl with her lips burned by the acid.

Miss Palmer was committed to the home by the Juvenile court one year ago. Her father and mother live in Union county, and were adjudged unfit persons to be entrusted with her care. Since taken away from her mother she is said to have been most unhappy, and during the past year in the society home has been treated twice by a physician for hysteria.
