LIKES UNION COURT HOUSE.

Wallowa Inspectors Find Nothing More Suitable to Copy After.

Wallowa county will pattern after the Union county building in the matter of constructing a court house. The following from the Wallowa Sun:

County Judge-elect J. B. Olmsted and Commissioner Sam Litch returned Friday morning from a week's trip examining court houses at their own expense with a view of gaining ideas that would be of value when it comes to building the Wallowa county court house. They were at La Grande, Pendleton, Heppner and Walla Walla.

The building at La Grande comes nearest answering the requirements of this county both in arrangements and cost. With a few changes the Union county court house will fill the bill here said Commissioner Litch Friday morning. That structure cost about \$25,000 or \$26,000. The court house at Pendleton, while a handsome building, is antiquated in its interior arrangement. The one at Heppner did not suit at all and besides, cost about \$60,000. They went to Walla Walla principally to inspect the jail which is considered a model in its arrangement.

The present talk is to construct a two-story and basement building, the basement to contain the heating plant, fuel rooms and storage vaults. A jail would be included in the main building.

ADVERTISING FOR FEDERAL BUILDING SITES.

Treasury Department, Office of the Secretary, Washington, D. C., June 8, 1908.

Proposals will be received, to be opened at 2 o'clock p. m., July 16, 1908, for the sale or donation to the United States of a suitable site, centrally an conveniently located, for the federal building to be erected in La Grande, Oregon. A corner lot, of (approximately) 130x135 feet is required. Each proposal must give the price, the character of foundations obtainable, the proximity to street cars, sewer, gas and water mains, etc., and must be accompanied by a diagram indicating the principal street, the north point, the dimensions and grades of the land, the widths and paving of adjacent streets and alleys, whether the alleys are public or private, and whether or not the city owns land occupied by sidewalks. The vendor must pay all expenses connected with furnishing evidences of title and deeds of conveyance. Improvements on the property must be reserved by the vendor; but pending the commencement of the federal building they may remain on the land upon payment of a reasonable ground rent. The grantor must, however, remove all improvements on thirty days' notice so to do. The right to reject any proposal is reserved. Each proposal must be sealed, marked "Proposal for federal building site at La Grande, Oregon," and mailed to the secretary of the treasury, (supervising architect), Washington, D. C. No special form of proposal is required or provided.
