# UNIVERSITY NEWS ITEMS

University of Oregon, Eugene, Sept. 29.—Special.—The university will issue in a short time the second number of its bulletin on Correspondence Study courses. The correspondence work last year met with so encouraging a reception and the demand for it was so great that the department has been greatly strengthened and many new courses are being offered. It is believed that 3000 students will enroll for this work between now and the first of January.

**Increase of 30 Per Cent.**  
The first two days' registration at the University of Oregon has been the greatest in the history of the institution. Already nearly 475 students have enrolled, which is greater than the total enrollment for the whole of last year. A large number of old students will return within the next two weeks, and the total enrollment for the year will reach 550, or an increase of 30 per cent over last year.

**Fifty in Moleskins.**  
Coach Robert Forbes, the famous Yale end, who was hired by the Associated students of the university, to coach their football team, is making a great hit with his men. Fifteen men are turning out for practice daily.  
**Freshies Number 250.**  
The Freshmen class at the university numbers nearly 250 members.

### M'KINNEY MAY COACH.

Baker City's Rudderless Team May Soon Have Coach.

Henry McKinney, one of the star players on the University of Oregon football team, may be secured to coach the football team of the Baker high school, says the Herald. Jim Nichols, who has made such a reputation with the team during the past three years, is unable to coach this year and an effort is being made to secure McKinney to look after the boys who will represent Baker high.

There is a strong sentiment among all who take any interest in high school affairs for McKinney and much influence is being brought to bear on him to accept. He has taken the matter under advisement and the boys will know shortly if they are to be guided by him. As an all around athlete McKinney ranks among the best on the coast and as a football player he was one of the greatest men that ever played on the university team. He understands all the intricacies of the game, and knows how to get the best results from all the men. With such a coach Baker would again be assured of the fastest high school team in the state, and McKinney should be secured by all means. Baker high has the material for a championship team, the only thing lacking being the coach, and McKinney is the man.

### New Mining Companies.

Baker City, Sept. 29.—While there is little excitement in mining circles of Baker county and eastern Oregon at the present time, there is, nevertheless, something doing. Records at the court house today show articles of incorporation for two new companies recently formed for the purpose of mining in this county.

One is the Humboldt Gold Mining company, with Fred R. Mellis, James A. Howard, John Arthur and Kenneth O. McEwen as incorporators. They organize for the purpose of locating, leasing, buying, selling, developing and operating mining property. The Humboldt mines are located in the Mormon basin. One thousand shares of stock of \$100 each constitutes the capitalization.

The Zenith Gold Mining company is another company born today, when articles of incorporation were placed on file. Don L. Lillard, J. N. Hart and C. H. McCulloch are named as incorporators. The company is capitalized for 1,000,000 shares of \$1 each. Offices are to be maintained at Sumpter, Ore., and Ybor, Fla.
