Ordinance No. 399, Series 1908.

An ordinance prohibiting the sell-

City of La Grande does ordain as

effect, sell, exchange or give away any intoxicating liquor of any kind, or in any way violate any of the provisions of this ordinance, within the city of La Grande, Oregon, shall upon conviction thereof before the recorder, be punished by a fine not less than \$50.00 nor more than \$300.00, or by imprisonment in the city jail for not less than 25 days nor more than 150 days. If any perosn shall be convicted a second time for violating any of the provisions of this ordinance, such person shall be punished for the second and each subsequent violation of this ordinance, by both such fine and imprisonment.

Sec. 2. The provisions of the foregoing section shall not be so construed as to prohibit the sale of wines to church officials for sacramental puroses, nor alcoholic stimulants as but such stimulants shall only be sold upon the written prescription of a regular practicing physician who follow the practice of medicine as a principal and usual calling, dated and signed by him, and certified that he has personally examined the applicant, giving his name, and that he finds him actually sick, and in need of the stimulant prescribed as medicine; provided, that no person shall be permitted to sell more than once on the prescription, nor on a prescrip- this week only, 85 cents per crate, at tion which is not dated, signed and Conley warehouse, or \$1 per crate decertified as above provided; provided further, that every person selling such stimulant upon the prescription herein provided for, shall cancel such prescription by endrosing thereon the words "Cancelled" and the date of cancellation, and shall file the same

But nothing in this ordinance shall e construed to prevent one registered pharmacist selling such alcoholic liquors to another registered pharma-

Sec. 3. This ordinance shall be published in one issue of the La Grande Evening Observer, and after ts approval by the mayor be in full orce and effect on and after the 4th lay of January, 1909.
