ship, Attorney W. M. Ramsey will have to purchase his partner in business. When Mr. Ramsey was chosen and he was an individual and not as a member of a firm, hence there will be no legal entanglement from that score.

Failed to Meet Payments.

Turner Oliver did not meet the first assessment which was due December 19. He offered to compromise the whole item for \$1900. In this he was flatly refused consideration by the receiver. The time limit for the first payment had expired.

Then the long letter was sent asserting definitely that the writer refused to meet the assessments. In the opinion of the receiver and the attorney for the bank, there is no question but what Mr. Oliver refused to pay his assessments. Finally after the expiration of an assessment is bankruptcy from the government for holding stock in a failing bank.

The matter did not come to a focus before the court, which is 15 days later in, and 15 days later, the legislature is in actual session. As a result of this proceedings will have to await the expiration of the assessment period.

The Sum Required.
