# LOW RATES TO OREGON

THERTY MILLION IN ON 825 RATES TO OREGON.

Time to Redouble Advertising, as an Enormous Influx of People is sure to Pollow Advent of Extremety Low One-Way Rates—Other Oregon Booster Items.

Portland, Jan. 18.—(Special correspondence.)—No news that has been received by the people of Oregon during the last 24 months is so important as the announcement that the transcontinental railroads will make a rate, beginning March 1 and continuing until April 30, from Kansas City, Omaha, St. Paul and Minneapolis, Winnipeg and other similarly situated towns, to all main line railroad points in Oregon, for \$25.

The people of no state in the union have profited more by these one-way tickets than have those of Oregon during the last four years. The rate from Chicago is \$33, from St. Louis \$39.50, with a proportionate low fare from all points in the United States. This should add many thousands of actual settlers to the population of Oregon. These are one-way tickets, and if travelers desire to return to their former homes in the older eastern states they would have to pay full fare.

Every commercial club and advertising bureau in the state, as well as every real estate firm, should begin immediately to advertise these rates.

Every citizen of Oregon should write personal letters to old friends and a qualitances reminding them that the rate is good to their town. But the ticket must be bought to the point of destination—it's just as cheap to the most distant Oregon point as to one just over the border of the state.
