Washington, Jan. 18.—The Texas anti-trust law passed by the Texas legislature, originally in 1901, and later amended in 1903, was today held to be constitutional by the supreme court. The case in question was the appeal by the Waters-Pierce Oil company, in which the company was fined \$1,623,500 for alleged violation of the anti-trust law.
