#### NATIVE SON AFTER CHAIR

Portland, Jan. 28.—(Special.)—Grant B. Dimick, for the last three years county judge of Clackamas county, and for five years mayor of Oregon City, has announced his candidacy for the republican nomination for governor of Oregon, after being urged by many people from all parts of the state to make the run.

His friends feel that should he be the nominee of the party of his adoption, no issue could ever be made about his being of foreign birth, or about his true Americanism, since he was born on a farm on Padding river, in Marion county, Oregon, the son of one of the most prominent G. A. R. men who ever drew sword in his country's behalf. He was admitted to the bar of Oregon in 1895, and located the following year in Oregon City, where he has established himself firmly in the hearts of the people of that city and county. He has successfully filled the office of deputy district attorney two years, mayor of Oregon City five successive terms, and has served as county judge for over two years. In 1904, he was a presidential elector on the republican ticket, speaking in many sections of the state, and received over 40,000 plurality.

The Oregon City Enterprise, in the issue announcing the candidacy of Judge Dimick, has a long editorial, speaking in very eulogistic terms of him, and pledging 5000 votes solid from "Old Clackamas." It is very early for candidates for governor, since the primary election deciding this contest will not take place until in September, 1910, but evidently the Clackamas man feels that if the "early bird catches the worm," the prize in this case should be his.

Many distinguished representatives of the legal profession in the Sunflower state are in attendance and will respond to toasts at tonight's dinner.
