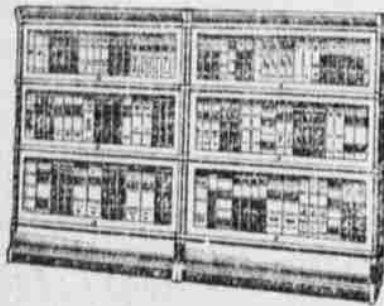

of 40 per cent—whatever the dividend will be—amounts to the full out the individual checks. Once more the checks start across the continent. At Washington they will be again checked up separately, and signed by the comptroller. By the time they reach here, a month's time at the very latest will have elapsed.

Size of the Dividend.

The dividend to be issued in March will be 40 per cent at the lowest, and may reach 45 per cent, but not likely the 50 per cent mark. With 40 per cent payments, the sum to be distributed will be \$194,000, and if 45 per cent dividends then \$106,000, as the total liabilities are \$226,000, approximately.
