In the Justice's Court for La Grande District, Union County, Oregon. J. W. White, plaintiff, vs. William Dye, defendant.

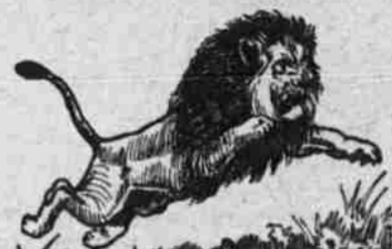
To William Dye, Defendant above named, Greeting:
