BAKER WILL PAVE.

Three Miles of Streets Will Be Improved Immediately.

Baker City, March 17.—Initial steps were taken at the council meeting last night for the paving of three miles of Baker streets. Ordinances were passed instructing the city engineer to prepare plans and specifications for the improvement of Front, from Auburn to Baker; First, from Place to Center; Dewey avenue, from Auburn to the O. R. & N. railroad; Center street, from Resort to the O. R. & N. right of way; Washington, from Resort to the O. R. & N. right of way; Court, from Resort to Fourth; Valley avenue, from Resort to Second, and Auburn avenue, from Resort to Second street. The emergency clause was attached to each ordinance, so that the city engineer may proceed at once with the work. As soon as the estimates are prepared, the council will probably call for bids, so that the improvements may be completed before cold weather comes again.

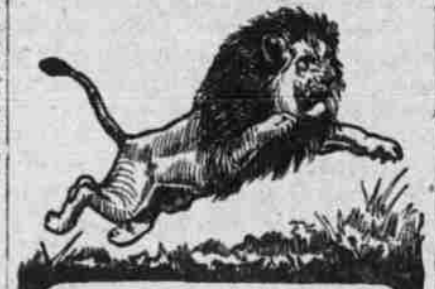
To William Dye, Defendant above named, Greeting:
