LEAGUE OF SIX TEAMS

At Baker City last Sunday a six team baseball league was formed, with Baker City, La Grande, Cove, Huntington, Perry and Union in the circuit. With the exception of the Fourth and Labor Day all games will take place on Sunday. While the schedule is not definitely decided upon with respect to a few dates, it is certain that La Grande fans will have an opportunity to attend a game every Sunday until the end of the season, at present set for September 6. All the Perry games will be played on the Lincoln park grounds. Next Sunday La Grande goes to Huntington, Cove to Union, and Baker City will play Perry here. As the schedule is now arranged, 10 games are all that will be played on any but the local diamond, where, with the Perry games, there will be 21.

The different teams will meet at La Grande, Baker City and Union on the fourth.

The names of the managers of the different teams are as follows: La Grande, Lincoln; Baker City, Muegge; Perry, Olsen; Cove, Stock; Union, Phillips; Huntington, H. H. Mack.

La Grande vs Enterprise.
Archie Miller, of Enterprise, is in La Grande today. Mr. Miller is an ardent fan, likewise George Cleaver. These two gentlemen met this morning. Mr. Miller is a booster for the county seat of Walla-walla county, and his enthusiasm extends throughout the whole county. Mr. Cleaver believes in La Grande and the prowess of her sons.

The conversation naturally turned to baseball. It was a short step to the issuance of a challenge from one to the other, the teams to be made up of former players now over the age of 30.

The exact date of the game is not yet decided upon, but it will probably occur sometime during the carnival week. Also the personnel of the teams has not been settled, but Mr. Miller hopes to find a fair aggregation by selecting from Enterprise, Walla-wa and Joseph. In La Grande there is plenty of material, but it is likely that Mr. Cleaver will try to pick only an average team and not an all star bunch.

INCREASE IN TRAVEL

For the first six weeks of the Spring colonist season an increase of 50 per cent has been maintained. Figures for the first two weeks of April bring the total for 1900 up to 9479 home-seekers who have come to the Oregon country via the Harriman lines, as against 6379 for the same period last year.

The record, since March 1, this year, is only a few hundred under the entire aggregate for the whole season of 1908, when the total was 10,041. The gain for the two weeks in April, just reported today, over the same fortnight, a year ago was 1149, the totals for the two weeks being 2967 for 1909 and 1927 for 1908.

Between April 1 and 15 Portland alone had secured 707 new home builders from the East and towns in Willamette Valley got 426, Hood River 16, Pendleton 29, La Grande 36, Elgin 29, Baker City 45, Walla Walla 38, Lewiston 29 and Shaniko 21.

With three weeks more to be heard from it is now absolutely certain that all former records for the movement of colonists to this territory will be broken this year.—Portland Telegram.

Elgin Water Pipe Damaged.
The main pipe supplying water for domestic and fire purposes in Elgin is badly out of line, as a result of a land slide that has been taking place for several weeks, and in several places the pipe has been nearly disconnected, threatening the citizens with a water famine. New pipe has been received and work of repairing the damage has been commenced.
