## CARRIER IN BUZZ WAGON

WESTON, Ore., May 12.—Today Jesse Powlis, rural carrier on rural route No. 2, from Weston postoffice, started out to serve his patrons on the route with his new horseless carriage. In all probability this is the first route to be served in Oregon with an auto. A trial trip was made last evening and as the roads were muddy from the late rain and on the mountains several inches of snow was encountered and through it all up Hill and down, the machine proved its efficiency, making the 30 miles in about three hours. Mr. Powlis accepted the machine and from now on will use it in his work.

It is a high wheel 20 horse power, of the International company's make, and was purchased from the Tierney-Toney company of Walla Walla. With this outfit the carrier is enabled to serve his route in at least four hours to four and a half, giving him the balance of the day to devote to other interests if so inclined. With high prices for horse feed and the necessity of keeping at least four head of horses to do the work it is believed that the cost of running the "benzine buggy" will make a saving of a good many dollars yearly, much more than the interest cost on his investment.
