HONOR COMES TO SON OF ATTORNEY RAMSEY

The Rev. Horace M. Ramsey, Vicar of the Pro-Cathedral of St. Stephen the Martyr, at Portland was the recipient of the degree of B. D. at the General Theological Seminary at New York city a few days ago, at the regular seminary commencement. Mr. Ramsey received his B. A. degree from the Pacific University at Forest Grove, Oregon, in 1899, and his M. A. degree at the University of California, in regular course in 1902. He was Temple Emanuel Fellow of the University of California when a student there. He took his regular three years' theological course at the seminary at San Mateo, Cal., where he graduated in 1902, and he was then ordained Deacon before he was twenty two years old. In the summer of 1902, he was elected Eigenbrodt Fellow of the General Theological Seminary at New York and went east where he did graduate study nearly two years in N. Y., living at the seminary and dividing his time between the seminary and the Columbia University. In 1904, he went to Germany for and was a student at Marburg University for one year, and then visited other European countries. He returned home in 1905 and has had charge of his church in Portland since that time. He held the fellowship last above named three terms. It yielded him about \$650.00 per annum, which he applied on his expenses. While he was at the seminary in N. Y. he did the work required for the B. D. degree at that seminary. Only a small per cent of the students at that seminary obtain this degree, because, in addition to the other requirements, a special knowledge of the Hebrew, Greek and Latin languages, is necessary to receive this degree. It is never conferred as an honorary degree by that seminary.

Mr. Ramsey is a native Oregonian, and is not yet twenty-nine years old, he is also a son of Attorney W. W. Ramsey of this city.
