commence this important work today, by reason of the fact that the instruments ordered from Portland, and necessary in carrying out the work from this stage, did not arrive this morning and may not reach here until tomorrow morning. In the interim, no time will be lost for Mr. Darley has an abundance of office work that needs attention. "It's going, and going fast" is the way Secretary Cleaver recapitulated irrigation developments this morning, and the assertions are without a question of doubt, true beyond the fondest hopes of those who a year ago dreamed of such a project.

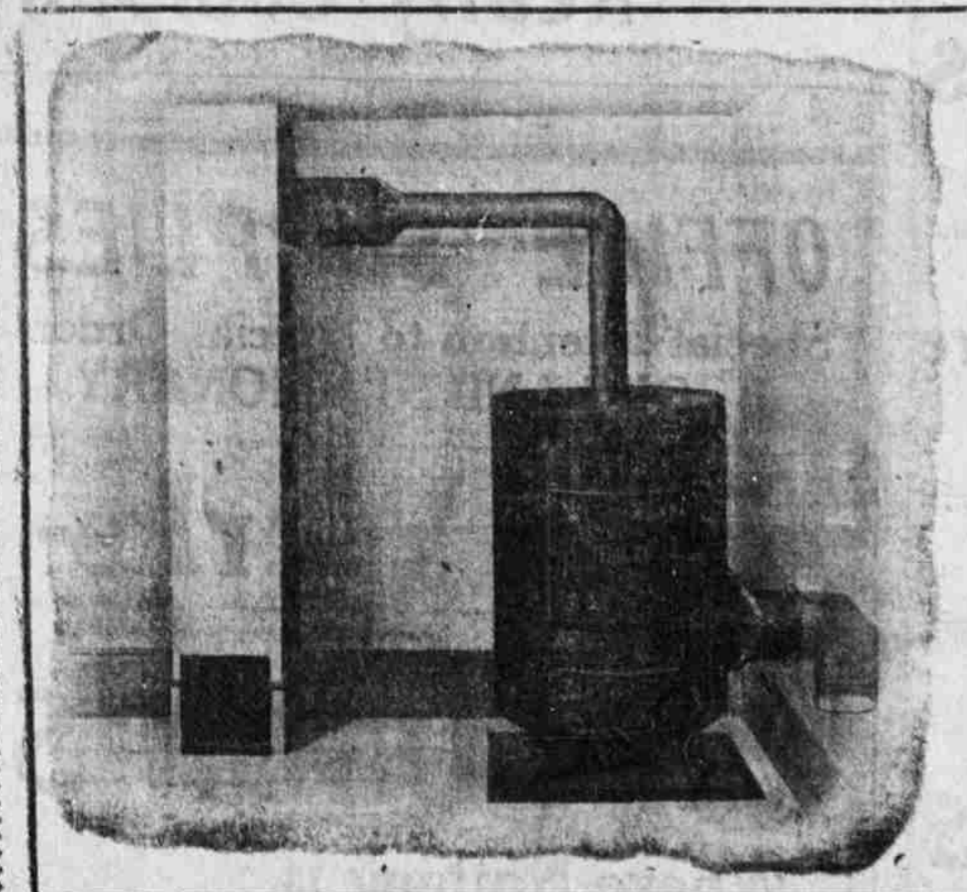
