BIG RUSH FOR LAND

There is a great rush for the 50,000 acres of Carey land which was held by the Harney Valley Improvement company for several years, but which was opened by the government for entry a few weeks ago. This tract is situated in the center of Harney valley, and is a fine body of grain land. The government decided that the land was not desert and that the improvement company could not get sufficient water to irrigate such a large tract, so it was opened to entry under the homestead law. Good crops are being raised on land joining the Carey land without irrigation and there is no doubt but what grain and alfalfa raising will be a success.

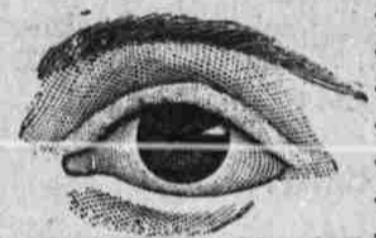
