## STEEL CHAIR CARS USED IN CONTESTS ON APPLICATIONS

The first steel chair car seen in La Grande, passed through yesterday on the belated No. 7. The car was the Los Angeles Limited, Union Pacific, and is similar to the steel mail cars which pass through every day.

Another steel chair car of the same pattern as went through yesterday, was on No. 7 this morning, indicating that while the rush is on, several of that sort will be drafted into service. They are invariably at the head of the train immediately behind the baggage cars and in case of a wreck will be a protection to the passengers.

The cars are very similar to the wooden coach, but so much more free from danger that the difference has been an incentive for several lines to put in large orders for them. It is predicted that in the near future all overland trains will be made up of the steel cars.

**Blue And Gray Clasp Hands.**  
UTICA, N. Y., Sept. 7.—Soldiers who wore both the blue and the gray during the domestic unpleasantness of the '60s met here today and buried the hatchet, preliminary to a peaceful pow-wow of three days. The occasion is the annual reunion of the survivors of Fort Fisher. Last year the New Yorkers went south and were the guests of their former foes in Dixie. Utica has determined to return the hospitality and every effort has been made to make the reunion one of the most notable affairs in the history of the city.

Today is the last day of the 10-day period in which inspection of claims on water right in Mill Creek at Cove can be made. Water Superintendent F. M. Saxton, who has charge of this section of Oregon under the water board will leave Cove today. C. E. Cochran attorney for three prospective water users, went to Cove this forenoon to file complaints and contests against as many applications, alleging extravagant claims.

During the 10 days in which inspection of claims can be made, several pending suits were adjusted, but three under Mr. Cochran's observations could not be adjusted out of court, and the contests filed today will be heard by the board. In case the outcome is objected to by either court, the cases will be carried to the circuit court.

### Comptroller Metz Back.

NEW YORK, Sept. 7.—Comptroller Metz returned from Europe today and was given an enthusiastic reception by his friends. The supporters of Metz now have little hope of securing the mayoralty nomination for him, and will probably concentrate their efforts toward landing a renomination for the comptrollership. Metz is said to believe that Judge Gaynor will be nominated for mayor by the Democrats.
