PREVENTION OF CONSUMPTION.

Appropriations of over \$4,000,000 for the suppression of consumption have been made by twenty-eight state legislatures in session during the past year, according to a statement issued today by the National association for the study and prevention of tuberculosis.

Since January 1, 1909, forty-three state and territorial legisatulres have been in session. Of this number, 28 have passed laws pertaining to tuberculosis; eight others have considered such legislation, and in only seven states no measures about consumption were presented. In all; 101 laws reof human tuberculosis were considered and out of this number 64 were passed.

Of the sixty-four laws passed; fourteen were in reference to building new state institutions. New state sanatoria for tuberculosis will be built in Pennsylvania, Connecticut, where three will be erected, Arkansas, Oregon, South Dakota, North Dakota and Florida. In New York, North Carolina, Indiana, Massachusetts, New Hampshire and Maine, appropriations have been made for enlarging sanatoria, already being built or in operation. There are now 27 states where such institutions have been established. Every state east of the Mississippi, except Illinois, West Virginia, Kentucky, Tennessee, South organ.-Osteopathic Her.lth. 


