## HAWLEY CASE INVESTIGATED

News has come from Baker City that Page Hawley's story of the beating he is alleged to have received at the hands of J. J. Burns and C. H. Spratt at Copperfield several weeks ago was sufficient to warrant the grand jury of Baker county to hand down an indictment against those men Friday, and on Saturday next they will come over from Copperfield and be arraigned.

The joint indictment against Burns and Spratt was one of four handed down Friday. The others were against J. R. Howard, who is indicted for manslaughter in the killing of John Hinds at Durkee; John Woods, indicted for forgery, and William Ott, for larceny.
