**Ordinance No. 438, Series 1909.**  
An ordinance providing for the submission to the legal voters of the city of La Grande, Oregon, at a special election to be called by the common council, the question of authorizing the Council of the City to issue and negotiate bonds in the sum of \$50,000 for the purpose of refunding bonds of the city in like sum, commonly known as the "Water Works Bonds" and to provide for the calling of said special election.

Whereas, there are bonds of the City of La Grande, in the sum of \$20,000 dated on the 10th day of December, 1889, bearing interest at the rate of 6 per cent per annum, which fall due on the 10th day of December, 1909; and

Whereas, there are bonds of the city in the further sum of \$30,000 dated on the 1st day of July, 1892, bearing interest at the rate of 6 per cent per annum, said bonds aggregating the sum of \$50,000 and commonly known as the "Water Works" bonds and

Whereas, the city is unable to pay said bonds, and is desirous of refunding the same at a lower rate of interest than said bonds are now bearing; Now, therefore:  
The City of La Grande Does Ordain as Follows:

Section 1.—That at a special election to be held in the City of La Grande, Oregon, on the 10th day of November, 1909, which election is hereby called by the Common Council by this ordinance,

there shall be submitted to the legal voters of the city the question of authorizing the council to issue and negotiate bonds in the sum of \$50,000 to run for a period of twenty years, to be redeemed and paid at any time after ten years, at the option of the city, to bear interest at the rate not to exceed 5 per cent per annum and to be paid, principal and interest, in United States gold coin, and to be sold at not less than the par value of said bonds.

Section 2.—That on the ballots used and voted at said election, there shall be printed the following question: "Shall the Common Council of the City of La Grande, Oregon, be authorized to issue and negotiate bonds of the city in the sum of \$50,000 to bear interest at the rate of not to exceed 5 per cent per annum to be sold at not less than par value of said bonds, payable both principal and interest in United States Gold Coin, to run for a period of twenty years from date, to be redeemed and paid, at any time after ten years from date, at the option of the city, which said bonds are to be issued and sold for the purpose of refunding bonds of the City in the said sum of \$50,000, commonly known as the Water Works Bonds.

Section 3.—There shall also be printed on said ballots, the words "yes" and "no", and the numbers "300" and "301"; which said words and numbers shall be placed on the ballots in the same form and manner, and said question shall be voted on at said election in the same manner as similar questions are voted on at state elections.

Section 4.—That said ballots shall be counted and the returns of the judges and clerks of said election shall be made and canvassed and certified, in the same manner as ballots used in the election of city officers are counted, and the returns of such elections are made, canvassed and certified.

Section 5.—That when the returns of said special election shall be made, canvassed and certified by the Recorder, if it is found that a majority of the votes cast on said question are in favor of authorizing the Council to issue and negotiate said bonds, the certificate of the Recorder to that effect shall be entered at length upon the minutes of the council, the original thereof filed in the office of the Recorder, and the mayor shall issue his proclamation declaring the result of said election.

Section 6.—That the Recorder shall and he is hereby directed to give notice of said special election, by publication thereof, by posting said notice in each ward in the City, for the period of ten days.

Section 7.—Inasmuch as it is expedient and necessary that this ordinance take effect at once, now, therefore, in order to preserve the peace and safety of the city, and to maintain its credit, an emergency is hereby declared to exist and this ordinance shall be in full force and take effect on the 30th day of October, 1909 on and after its approval by the mayor, after its publication in one issue of the La Grande Evening Observer.

Passed the common council of the City of La Grande, Oregon, on the 27th day of October, 1909 by six members voting therefor.
