LAWYERS CHAGRINED

"The Supreme Court of the State of Oregon is now in bad favor with the members of the Eastern Oregon Bar. The cause for the dissatisfaction is the promulgating of a new set of rules for the government of cases before the court and the enforcement of these rules at this term of the court, without the attorneys having been given any previous intimation of the changes. The rules were promulgated orally from the bench and the attorneys have not even as yet been furnished with copies of them.

The attorneys do not object to the changes in the rules but they do think it decidedly unfair for the court to insist on their enforcement at this time when they were led to believe that the same rules which have obtained in the past would still hold.

From the ruling made today it is evident that hereafter there will be few, if any Eastern Oregon cases transferred to Salem for argument. It is also evident that attorneys will not be permitted to make their arguments and then file their briefs later.

Another important change is the limiting of time for all arguments to two hours. The attorneys for the appellant will be allowed 45 minutes in which to open the case, the attorney for the respondent will be allowed an hour and then the appellate attorney will have 15 minutes in which to close.

STOCK KEPT OFF STREETS

BIG REDUCTION IN RECEIPTS OF POUND MASTER.

Only Two Contagious Diseases Reported Last Month.

From the report of the poundmaster which will be submitted to the city council tonight it is evident that La Grande has progressed beyond the green pasture stage of its development and that the people are taking to keeping their stock off the streets. The report will show only five dollars collected during the month of October from cattle or horses taken up. One year ago the sum collected for the month was \$46.00.

Only two cases of contagious disease will be reported. oth of these cases are of scarlet fever and are under quarantine.
