A FIRM EXECUTIVE.

Without doubt Governor Benson's most trying hour in the history of his official duty, was in refusing to pardon Finch. It was a far different position to that of the juror who heard all the evidence at the trial and followed the instructions of the presiding judge, disagreeable as that was, when knowing that the verdict of guilty meant a death penalty if carried out.

But when the mother and wife of a condemned man make a plea for those they love, it requires a man of strong convictions to do what he actually knows to be his duty. Governor Benson carefully reviewed the circumstances and let the law take its natural course. Human life is very cheap in the United States. Few countries there are in which as many murders are annually committed as in our own and few indeed as compared with the homicides does capital punishment follow. Our courts are so technical that too often men with money or influence go unpunished, that the fear of the gallows has lost its terror.

A BELIEVER IN ATHLETICS.
