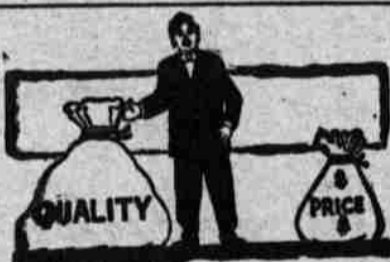

YOUTH BOUND OVER

Passes bogus check for \$125.50 on R. S. & Z.

Walter Nelson of Union, a 19-year old boy who has been working on ranches in this county for a year past, was bound over to the circuit court Monday, by Justice A. C. Smith in the sum of \$100 on a charge of forgery, says the Enterprise News-Record.

The evidence at the examination is that Nelson had uttered a forged check for \$125.50, purporting to be signed by W. A. Dorrance, drawn on the First Bank of Joseph in favor of T. J. Jones. The check was first presented by Nelson to the Wallowa State Bank in this city Saturday afternoon, but Cashier W. R. Holmes refused payment as he believed the signature was not genuine. Nelson then went to the R. S. & Z. store and bought \$42.25 worth of goods, clothing, shoes, etc, receiving as his change \$50.25 in cash and the R. S. & Z's check for \$35. Mr. Steele found out the suspicious nature of the check when a little later he took the store deposit over to the bank and a phone message to Dorrance confirmed the forgery. Nelson had endorsed the check to the R. S. & Z. in the name of J. T. Jones.

Mr. Steele and Marshal Hug went to Joseph on the delayed train and captured the man there. All of the clothing the \$35 check and \$39.55 of the money were recovered. Nelson is in jail in default of bondsmen.

Winter Does Not Stop Building.

No residence sections of the city are improving so fast as Alder View in the southwest and Boyd's subdivision in the west. The former especially is being rapidly built up with a fine class of houses—pretty cottages and fine large residences. Building has gone on even during the cold weather of this unprecedented winter.

Killed by Snowslide

Coruncoia, Feb. 24.—In a terrific snow slide that occurred this forenoon in the Coruncoia mountain range, Robert Wilson one of the oldest and most highly respected miners of this camp met death and is buried under many feet of snow and ice.

The slide started well up the mountain side and with the speed of a meteor dashed downward breaking large trees the same as though they had been matches. It struck the Union Company mine bunk house and completely wrecked it, rolling it over and over as the timbers were crushed and twisted. Robert Wilson was in the path of the slide and he could not reach a place of safety.

The noise made by the slide resembled a distant canonading and the snow and ice filled the air marking the course of the slide through the atmosphere.

At this time it is hard to estimate the amount of damage done to property.
