Surrounding Country.

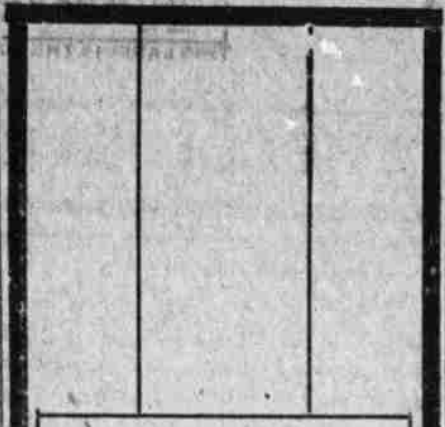
